The Family Timeline Database is a single-file software application delivered as a downloadable **.html file**. It runs entirely in your web browser — no installation, no internet connection, and no subscription is required after purchase.

Your purchase grants you a **personal, non-transferable license** to use this file for your own household or family history project. You may not resell, redistribute, sublicense, or share the file with others outside your immediate household.

Tip: If you are using Firefox or Safari, use the *Export to File* button regularly to back up your data to a .json file on your computer. Data stored only in the browser may be lost if you clear your browser history or cache.

The Family Timeline Database stores all of your information on **your own device** — nothing is sent to any server, cloud service, or third party. This means:

- You are solely responsible for backing up your data.
- If you clear your browser's cache or storage, data not saved to a file may be permanently lost.
- If your device fails, is lost, or is replaced, data not backed up externally cannot be recovered.
- Save A Memory is not liable for any loss of data, regardless of cause.

Best practice: After each session, use the Save to File button to save your timeline to a .json file. Keep a copy of that file in a separate location (an external drive, cloud storage, or email to yourself).
