

## Why Having an Agreement Is Essential in a Service-Based Business

In any service-based business—whether you're building websites, designing brand assets, offering coaching, doing consulting, or managing memberships—relationships rely heavily on **expectations**, **deliverables**, and **communication**. An agreement is the tool that keeps all three aligned.

Think of an agreement not as a stiff legal document, but as a **mutual understanding of the scope of work and/or services in writing**.

It creates clarity, boundaries, and protection for *both* you and your client. Even the most well-intentioned projects can go sideways without structure, and agreements help make sure the project stays on track for both you and the client.

### Before You Begin

**Write down the scope of the project first:**

1. What will the projects entail.
2. The timelines of roughly how long the project will take to complete. (Buffer the time here to ensure you can meet the timeline.)
3. The cost or a breakdown of the cost of there are installments.
4. What will the client's responsibilities be. (Content/homework/images etc. with a timeline of when you need them to stay on task.)
5. What will happen if the timeline is extended. (Cost/how much longer the project will take, etc.)
6. Any added costs if the scope of the work goes beyond what is noted here.
7. What will happen if either party does not comply. (Extra cost, extended timeline, or possible cancellation of project, etc.)
8. Ensure you note will happen if the agreement is cancelled. (i.e., refunds if any, how items that are part of the project are returned or deleted, etc.)

# Why Agreements Matter

## 1. They Define the Scope of Work (what's included vs. what's not)

Service businesses often struggle with “scope creep”—when clients request extra work that wasn't part of the original plan.

An agreement outlines:

- What services are included
- What deliverables the client will receive
- What timelines or milestones apply
- What requires an additional fee

This prevents confusion and protects your time, energy, and profitability.

## 2. They Protect Your Time and Income

Your agreement can specify:

- Payment schedules
- Late payment fees
- Deposits or retainers
- Cancellation policies
- Refund policies

This ensures you get paid fairly and on time and helps minimize financial risk.
