**Notice of Right to Object to Interpreter Appearing Remotely
(Civil Cases other than Ch. 48, 51, 54, 55)**

An interpreter has been requested by a party in this case. The interpreter will appear by telephone or live audiovisual means for all court events including any trials that may occur. This means that the interpreter will not be physically present in the courtroom when they are interpreting.

This form serves as notice that, pursuant to Wis. Stat. 807.14, any party may object to the interpreter appearing by telephone or live audiovisual means and may request that the interpreter appear in person. To allow adequate time for review, an objection to the interpreter appearing by telephone or live audiovisual means and the reasons supporting the objection should be filed at least 3 days prior to the scheduled hearing. The court will then decide how the interpreter will appear.
