

Privacy Policy

This Privacy Policy ("Policy") applies to Solidifiedrock.com, and [Solidified Rock Concierge Co.](#) ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [insert website here]. The Company's website is a Real Estate Virtual Assistance site. By using the Company's website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties.

The Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to the Company, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

The company may automatically collect information about your computer hardware and software. Security of Your Personal Information

- SSL Protocol

We strive to take appropriate measures to protect against unauthorized access to or alteration of your personal information. Right to Deletion

- Comply with certain state's Electronic Communications Privacy Act;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise, use your personal information internally, in a lawful manner that is compatible with the context in which the consumer provided the information.
