



FINANCIAL NIGHT LIFE SERVICE AGREEMENT

This Agreement is entered into on [DATE], by and between Financial Pain Night Life, a company providing services nationwide, and Client:

1. SERVICES PROVIDED

Financial Pain Night Life agrees to provide entertainment, nightlife, and event-related services, including but not limited to:

- Organizing and coordinating nightlife events and experiences
- Providing access to entertainment venues, parties, and special events
- Assisting with VIP services, reservations, and event arrangements
- Offering promotional services for nightlife activities and entertainment experiences
- Providing recommendations and strategies for enjoyable and safe nightlife experiences

All services are performed in compliance with applicable federal and state laws and may be delivered remotely or in person.

2. LEGAL COMPLIANCE

Financial Pain Night Life operates in compliance with applicable federal and state consumer protection laws. Client understands that federal and state laws govern this Agreement. Certain states provide additional consumer protection. No provision of this Agreement overrides those rights.

3. IMPORTANT DISCLOSURE

- Client has the right to review all event, reservation, and service details before participation.
 - Financial Pain Night Life does not guarantee admission to any venue if venue policies or legal requirements are not met.
 - Client is responsible for complying with all venue rules, age requirements, and applicable laws.
 - Client is not required to purchase any additional services from Financial Pain Night Life to participate in any event or experience.

4. NO GUARANTEE

Client understands that Financial Pain Night Life makes no guarantees regarding specific experiences, venue availability, VIP access, entertainment quality, or any specific outcome from participation in nightlife activities or events.

5. FEES AND PAYMENT TERMS

Client agrees:

- No payment is due until your nightlife and entertainment services have been fully performed, as required by federal law and Pennsylvania state laws.

Alternative (Use Only Where Allowed by Law)

Financial Pain Night Life will not charge or collect fees in violation of applicable federal or Pennsylvania state laws.

6. CLIENT RESPONSIBILITIES

Client agrees to:

- Provide accurate, truthful, and complete information
- Follow venue rules, event policies, and applicable laws
- Not engage in disruptive, unlawful, or misleading behavior
- Maintain respectful conduct during events and nightlife activities
- Cooperate with Company requests and event guidelines

7. TERM AND TERMINATION

This Agreement is month-to-month and may be canceled at any time by either party with written notice.

8. RIGHT TO CANCEL

You may cancel this Agreement without penalty or obligation within three (3) business days after signing. To cancel, Client must submit written notice via mail, email, or other agreed method.

9. LIMITATION OF LIABILITY

Financial Pain Night Life shall not be liable for any indirect, incidental, special, or consequential damages related to nightlife events, entertainment activities, venue access, or third-party services.

10. GOVERNING LAW

This Agreement shall be governed by:

- Federal consumer protection laws
- The laws of the State of Florida
- AND the mandatory consumer protection laws of the Commonwealth of Pennsylvania



11. PENNSYLVANIA STATE-SPECIFIC DISCLOSURES

PENNSYLVANIA RESIDENTS

An additional notice titled "Consumer Rights Under State and Federal Law" will be provided as required under Pennsylvania law.

TEXAS RESIDENTS

Client has the right to review a copy of the contract before signing and may file complaints with the Texas Attorney General.

NEW YORK RESIDENTS

Services may be subject to additional restrictions and required disclosures under New York law.

GEORGIA RESIDENTS

Financial Pain Night Life will comply with all applicable Georgia consumer protection and business operation requirements.

12. ENTERTAINMENT SERVICES DISCLAIMER

Financial Pain Night Life is not affiliated with any nightclub, entertainment venue, promoter, or third-party establishment unless otherwise stated in writing.

13. ENTIRE AGREEMENT

This Agreement represents the entire understanding between the parties and supersedes all prior agreements.

14. SEVERABILITY

If any provision is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.
