

YOUR LIMITLESS LIFE NETWORK TERMS OF SERVICE

Effective Date: June 3, 2026

Welcome to Your Limitless Life Network (“YLLN,” “the Network,” “we,” “our,” or “us”).

These Terms of Service (“Terms”) govern participation in and use of the Network’s television programming, distribution, websites, educational resources, host services, promotional platforms, events, and related offerings.

By participating in or using any portion of the Network, you agree to these Terms.

1. PURPOSE OF THE NETWORK

Your Limitless Life Network exists to provide a collaborative media and television platform designed to elevate purposeful voices through visibility, education, inspiration, collaboration, and professional media exposure.

The Network is committed to maintaining a professional, ethical, growth-oriented, and community-centered platform experience.

2. ELIGIBILITY

Participants must:

- Be at least eighteen (18) years of age
- Have legal authority to enter into binding agreements
- Provide accurate and truthful information
- Comply with all applicable laws and regulations

3. HOST PARTICIPATION

Participation as a television Host requires execution of a separate Host Participation Agreement.

The Network reserves the right to approve, deny, suspend, or terminate participation at its discretion to maintain platform quality, professionalism, operational integrity, legal compliance, and alignment with Network standards.

4. PAYMENT TERMS

Certain Network services and participation opportunities require payment of fees pursuant to applicable agreements.

Unless otherwise agreed in writing:

- Participation fees are non-refundable

- Recurring payments shall be automatically processed
- Failure to maintain payment obligations shall result in suspension or termination of services
- The Network reserves the right to modify pricing or participation structures with reasonable notice

5. ONBOARDING & LAUNCH REQUIREMENTS

Hosts are responsible for timely completion of all onboarding requirements, including:

- Forms
- Branding materials
- Technical setup information
- Promotional assets
- Requested approvals and documentation

Projected launch dates are contingent upon timely completion of onboarding requirements.

The Network shall not be responsible for delays caused by incomplete or late onboarding submissions by Hosts.

6. CONTENT SUBMISSION & TECHNICAL STANDARDS

Hosts are responsible for submitting broadcast-ready episodes and materials in accordance with Network technical specifications and submission deadlines.

Content may not include:

- Unlicensed materials
- Unlawful content
- Defamatory or deceptive content
- Excessively offensive material
- Content violating copyright, trademark, FTC, advertising, or platform regulations

The Network reserves the right to reject, delay, remove, edit for technical compliance, or refuse content that does not meet operational or legal standards.

7. SPONSORSHIPS & ADVERTISING

Hosts may secure sponsors and promotional partnerships for their programming.

Sponsor mentions, acknowledgments, interviews, endorsements, and integrated promotional discussions are permitted when presented organically within show content.

However, due to Roku and Amazon Fire TV platform policies, and applicable advertising regulations, Hosts may not include:

- Traditional commercial breaks
- Standalone commercials
- Inserted third-party advertisements
- Separately produced advertising spots

The Network reserves the right to require modification or removal of sponsorship material that violates platform requirements, legal standards, or Network policies.

Hosts remain solely responsible for compliance with FTC advertising guidelines and applicable laws governing endorsements and sponsorships.

8. INTELLECTUAL PROPERTY

Participants retain ownership of their original intellectual property.

By participating in the Network, participants grant the Network a non-exclusive, worldwide, royalty-free license to:

- Broadcast
- Display
- Promote
- Market
- Distribute
- Create excerpts and promotional clips for purposes related to Network programming, marketing, advertising, promotion, and distribution.

9. NETWORK BENEFITS & SERVICES

The Network may provide:

- Television distribution
- Educational resources
- Analytics
- Promotional support
- Landing pages

- Data capture tools
- Cross-promotional opportunities
- Community collaboration resources

The Network reserves the right to modify, replace, improve, suspend, or discontinue features or services at its discretion.

10. PRIVACY & DATA USE

Use of the Network is also governed by the Network's Privacy Policy which is incorporated herein by reference.

Hosts receiving viewer or lead data agree to:

- Use information responsibly
- Maintain confidentiality where appropriate
- Comply with applicable privacy and consumer protection laws

11. NO GUARANTEES

The Network does not guarantee:

- Audience growth
- Revenue
- Sponsorship acquisition
- Business growth
- Viewer engagement
- Media exposure
- Financial results
- Specific outcomes

Success depends upon numerous independent factors outside the Network's control.

12. DISCLAIMERS

The Network provides educational, informational, entertainment, promotional, and media distribution services only.

The Network does not provide legal, tax, medical, investment, financial, psychological, or other licensed professional advice unless explicitly stated.

13. PROHIBITED CONDUCT

Participants agree not to:

- Publish unlawful or infringing content
- Engage in harassment or abusive conduct
- Intentionally mislead viewers
- Violate advertising or FTC regulations
- Misrepresent credentials or endorsements
- Disrupt Network operations
- Repeatedly ignore operational requirements

14. LIMITATION OF LIABILITY

To the fullest extent permitted by law, the Network shall not be liable for indirect, incidental, consequential, special, punitive, or lost-profit damages arising from participation in the Network.

This includes, but is not limited to:

- Technical failures
- Platform interruptions

The Network may distribute programming through third-party platforms including Roku, Amazon Fire TV, social media channels, streaming services, podcast directories, and related technologies.

The Network is not responsible for outages, policy changes, restrictions, suspensions, or actions taken by third-party platforms.

17. TERMINATION

The Network reserves the right to suspend or terminate participation for:

- Violations of these Terms
- Nonpayment
- Illegal activity
- Fraudulent conduct
- Harmful behavior
- Repeated operational noncompliance
- Reputational concerns affecting the Network

18. FORCE MAJEURE

The Network shall not be responsible for delays or failures caused by circumstances beyond reasonable control including:
