This Privacy Policy explains how we collect, use, store, and protect information.

1. INFORMATION WE MAY COLLECT

We may collect:

2. HOW WE USE INFORMATION

We may use collected information to:

- Operate and improve Network services
- Process applications and participation
- Create landing pages and promotional materials
- Distribute programming
- Provide analytics and viewer insights
- Communicate with Hosts and viewers
- Process payments
- Deliver newsletters and marketing communications
- Improve platform performance and audience engagement
- Maintain legal and operational compliance

3. HOST LANDING PAGES & LEAD DATA

The Network may provide customized landing pages and viewer registration tools for Hosts.

Information collected through Host-specific landing pages may be shared with the applicable Host in accordance with the Host Participation Agreement.

Hosts receiving viewer information agree to:

- Use such information responsibly
- Maintain reasonable safeguards
- Comply with applicable privacy, advertising, and consumer protection laws

- Avoid unauthorized sharing or misuse of viewer information

The Network is not responsible for a Host's independent handling or use of data once shared pursuant to authorized Network processes.

4. CONTENT & PROMOTIONAL MATERIALS

Participants may provide:

By participating in the Network, participants grant permission for the Network to use such materials for:

5. THIRD-PARTY SERVICES & PLATFORMS

The Network may utilize third-party providers including:

Use of third-party services may also be subject to those providers' own terms and privacy policies.

6. DATA SECURITY

We implement reasonable administrative, organizational, and technical safeguards intended to protect personal information from unauthorized access, misuse, disclosure, or alteration.

7. COOKIES & ANALYTICS

Our websites and landing pages may use:
