

# DEPRECIATED VALUE PROTECTION COVERAGE

When you choose Premium Q Moving and Storage™ for your relocation, you can rest assured that your possessions have the best protection available. However, occasionally items may be damaged. That is why we offer **Depreciated Value Protection (DVP)**.

**Liability Based on Declaration of Value:** Liability is based upon your declaration of value made at the time of shipment. You may either limit our liability or declare full value. If you do not select an option, your shipment will be released with the minimum liability at 60¢/lb/article.

## TWO TYPES OF VALUATION COVERAGE

### MOST POPULAR

#### 1. Total Depreciated Value

This option covers repairs, replacement, or reimbursement based on depreciated value minus a **\$100 deductible**.

- ✓ **Repair:** Mover pays full cost of repairs.
- ✓ **Replace:** If not repairable, we replace with a like item.
- ✓ **Cash:** If not repairable, cash payment based on depreciated replacement cost.

### INCLUDED FREE

#### 2. Limited Liability

This is the minimum coverage required by the Government and provided free of charge.

- ✓ **Maximum Liability:** 60 cents per pound per article.
- ✓ **Calculation:** Recovery is the lower of depreciated value OR 60¢ × weight.
- ✓ **Note:** This is **NOT** full value insurance.

## 10lb CHAIR



### DAMAGE EXAMPLE SCENARIO:

If a 10 lb chair is damaged during relocation:

#### MOST POPULAR

**Option 1 (Total Depreciated Value):**

We repair, replace, or pay cash settlement (minus deductible).

#### INCLUDED FREE

**Option 2 (60¢/lb):**

Company is liable for a max of \$6.00 (10 lbs × \$0.60).



### STANDARD EXCLUSIONS

- ✗ Particle board / press board furniture (IKEA style).
- ✗ Items found broken in boxes **packed by owner** (PBO).
- ✗ Previously damaged or repaired items.
- ✗ Loose items not boxed by Premium Q Moving.
- ✗ If one item in a set is damaged, only that item is covered.
- ✗ Lamps, mirrors, glass, statues not packed by Premium Q Moving.
- ✗ Mechanical condition of electronics/batteries.
- ✗ Furniture with dried-out original glue.
- ✗ Live, artificial, or dried plants.
- ✗ Items delivered by a 3rd party company locally or interstate.

\* Shipper must avoid duplicate declarations. If two levels are entered, the Depreciated Replacement Value option shall control.

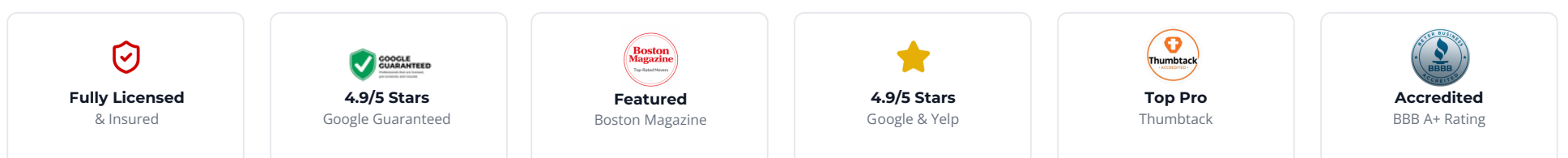
### Storage Liability

If Limited Liability is chosen, storage is covered at 60¢/lb. If Depreciated Value is chosen, the same coverage applies in storage at a cost of 10% of the transit valuation per month. Premium Q Moving and Storage™ acts as carrier during storage.


### Self-Packed Boxes


Premium Q cannot verify contents of owner-packed boxes. Liability for missing owner-packed cartons is limited to \$35.00 per carton. Crew-packed boxes are fully covered under selected option.
