

## Terms & Conditions

#### Promotion Period

The *Drive Into Spring* promotion commences from 8am AEST on Monday 10 August 2026 and concludes at 8pm AEST on Tuesday 29 September 2026. All eligible entries must be received during the promotional period.

#### Eligibility

Entry is open to members of Gosford RSL Club aged 18 years and over.

Non-members may join Gosford RSL Club during the promotional period to become eligible to enter.

Employees of Gosford RSL Club, including contractors, associated agencies, members of the Board of Directors and their immediate families are not eligible to enter.

#### How to Enter

To enter, eligible members must:

- Earn one (1) digital entry for every \$5 spent on eligible purchases during the promotional period.
- Receive double digital entries on eligible purchases made on Mondays, Tuesdays and Wednesdays during the promotional period.
- Present or swipe their membership card at the time of purchase to ensure entries are allocated to their membership account.

#### Entry conditions:

- To be eligible for any draw, members must activate their entries by swiping their membership card between 4:00pm and 7:55pm AEST on Tuesday 29 September 2026.
- Entries that are not activated during this period will be deemed invalid and will not be included in any draw.
- Gaming machine play, Keno, TAB, wagering transactions, ClevoQ spend, and any other purchases deemed ineligible by Gosford RSL Club are not eligible purchases and will not earn entries.

- Any entries awarded in connection with a transaction that is subsequently cancelled, refunded or reversed may be deemed invalid and removed from the promotion.
- Only entries issued through eligible purchases and linked to a valid membership account will be accepted.

## **Winner Selection**
