Terms & Conditions of Purchase and Use

Effective: May 1, 2026 | Last updated: April 29, 2026

These Terms & Conditions ("Terms") govern the purchase, delivery, and redemption of the Esthetic Finesse Mother's Day Gift Card ("Gift Card"). By purchasing, receiving, or using a Gift Card, you ("you" or "the Holder") agree to these Terms. Please read them carefully. If you do not agree, do not purchase or use the Gift Card.

These Terms are issued by Esthetic Finesse, located in Scottsdale, Arizona ("Esthetic Finesse," "we," "us," or "our").

Definitions

"Gift Card" means the Mother's Day promotional gift card sold by Esthetic Finesse during the campaign window.

"Purchaser" means the individual who pays for the Gift Card.

"Recipient" means the individual designated to receive and redeem the Gift Card. Where the Purchaser keeps the Gift Card for personal use, the Purchaser is also the Recipient.

"Paid Value" means the \$500 paid by the Purchaser at checkout.

"Promotional Bonus" means the \$100 promotional credit added by Esthetic Finesse at no additional cost.

"Total Credit" means the combined \$600 (\$500 Paid Value + \$100 Promotional Bonus) made available for redemption.

"Aesthetic Record" means the practice management system in which the Total Credit is held against the Holder's account.

1. Offer & Eligibility

The Mother's Day Gift Card offer is available for purchase from May 1, 2026 through May 11, 2026, or until 100 Gift Cards have been sold, whichever occurs first.

The offer is limited to one (1) transaction per Purchaser, with a maximum of three (3) Gift Cards per transaction.

Gift Cards may be purchased from any location but are redeemable only at Esthetic Finesse Scottsdale.

You must be 18 years of age or older to purchase a Gift Card. Recipients must be 18 or older to redeem injectable, laser, or other regulated services; we may decline service to anyone under 18 except where accompanied by a parent or legal guardian and where the service is age-appropriate.

2. Purchase, Issuance & Delivery

Gift Cards are issued upon successful payment processing. We accept major credit and debit cards through our secure payment processor (Stripe).

Upon purchase, the Purchaser receives an order confirmation email along with a printable PDF version of the Gift Card. The Purchaser may use the email and PDF to gift the Gift Card to the Recipient — for example, by forwarding the email or by printing the PDF and hand-delivering it.

The PDF and email are gifting tools only; they are not required for redemption. The Total Credit is held digitally in an Aesthetic Record account associated with the purchase (see Section 5).

It is the Purchaser's responsibility to provide accurate contact information at checkout. Esthetic Finesse is not responsible for delivery failures resulting from incorrect Purchaser contact details.

3. Value & Promotional Bonus

Each Gift Card carries \$600 in Total Credit, comprising \$500 Paid Value and \$100 Promotional Bonus.

The Promotional Bonus is a gift from Esthetic Finesse and has no cash value.

Total Credit is loaded to an Aesthetic Record account associated with the purchase upon successful payment and may be applied to services per Section 5.

The Total Credit is treated as a single redeemable balance. Where a refund affects this balance, the rules in Section 8 apply.

4. Expiration

The Total Credit (both the Paid Value and the Promotional Bonus) must be redeemed within twelve (12) months of the original purchase date.

Any unredeemed balance remaining at the end of the 12-month period is forfeited and may not be reinstated.

It is the Holder's responsibility to schedule and complete services within the 12-month window. Esthetic Finesse will provide reasonable reminders to the email address on file but is not obligated to extend the expiration date.

Esthetic Finesse does not impose dormancy or inactivity fees during the 12-month redemption period.

5. Redemption

The Total Credit is digital. There is no physical gift card, swipe card, or printed redemption code that must be presented at the time of service. The Total Credit is tracked in an Aesthetic Record account associated with the purchase.

Services are rendered in person at Esthetic Finesse Scottsdale, Arizona only. The Total Credit cannot be used at other locations or for remote services.

To redeem, identify yourself (or, if the Gift Card was given to you, the name and email of the Purchaser) at the time of booking or at the time of service. Esthetic Finesse staff will locate the corresponding Aesthetic Record account and apply available credit to the service total at checkout.

The Total Credit may be applied to any service or item offered at Esthetic Finesse Scottsdale at the time of checkout. There are no service-category exclusions on this Gift Card.

All services remain subject to provider availability, clinical suitability, and consultation. Esthetic Finesse reserves the right to decline or modify a service based on medical or clinical assessment, in which case any unused credit remains available on the account for future use within the 12-month redemption window.

6. Cash Value

The Gift Card has no cash value and cannot be redeemed or exchanged for cash, except where required by applicable state law.

The Promotional Bonus specifically has zero cash value under any circumstance.

7. Combining with Other Offers

The Total Credit may be applied to services that are otherwise eligible for promotional discount, but the Gift Card itself cannot be combined with other promotional gift card offers, package discounts that specifically exclude promotional credits, or stacked Mother's Day offers.

Esthetic Finesse reserves the right to determine, in its reasonable discretion, whether a particular promotion is combinable with the Total Credit.

8. All Sales Final

All Gift Card sales are final. Esthetic Finesse does not provide refunds for buyer's remorse, change of mind, non-use of the Gift Card, or any other reason not expressly listed in this Section.

Because the Total Credit is fully redeemable for twelve (12) months (Section 4) and may be transferred once by the Holder (Section 9), Holders have meaningful flexibility to use the value of their purchase. We consider these protections, together with our customer support, to be the equivalent of a refund in all ordinary circumstances. Notwithstanding the foregoing, Esthetic Finesse may, at its sole discretion, re-issue or refund a Gift Card in the following limited circumstances:

- Failure of delivery: the Purchaser does not receive the Gift Card email despite providing accurate contact details at checkout, and Esthetic Finesse is unable to successfully re-deliver after good-faith effort;
- Duplicate purchase: a verified technical error at checkout caused the Purchaser to be charged more than once for the same intended order;
- Confirmed fraud: the purchase was made using a stolen or compromised payment method, as confirmed by the cardholder and/or issuing bank;
- Where a refund or exchange is required by applicable law.

Where a refund is issued under this Section, the corresponding Total Credit is removed from the Aesthetic Record account. The Promotional Bonus has no cash value under any circumstance and is not separately refundable. Refunds, when issued, are processed to the original payment method less any non-recoverable payment processing fees, except where prohibited by law.

If you have a concern about your Gift Card, please contact us before initiating a payment dispute. Most issues can be resolved quickly through our support team (see Section 16).

9. Transfer

The Holder may transfer the unused balance of the Gift Card one (1) time, in writing, to another individual. The transfer must be requested by the Holder via email to support@estheticfinesse.com and confirmed by Esthetic Finesse before taking effect. Upon confirmation, the remaining Total Credit is moved to an Aesthetic Record account associated with the new Holder.

Subsequent transfers (i.e., from a transferee to another person) are not permitted.

Transfer is permitted only for Gift Cards that have not been refunded and on which a balance remains.

10. Fraud, Misuse & Right to Refuse

Esthetic Finesse reserves the right to invalidate any Gift Card obtained through fraud, misrepresentation, payment dispute, chargeback, or violation of these Terms.

Esthetic Finesse may refuse service to any Holder who is abusive toward staff or other clients, who poses a clinical risk during consultation, or who otherwise violates our standards of conduct, without obligation to refund or compensate the Holder.

Resale of Gift Cards by third parties (i.e., outside the original Purchaser-to-Recipient delivery) is not authorized and may result in invalidation.

11. Modification of Terms

Esthetic Finesse may modify these Terms from time to time. Material changes will be communicated to active Holders via the email address on file. Continued use of the Gift Card after notice of a change constitutes acceptance of the modified Terms.

These Terms reflect the version in effect at the date of purchase. Subsequent modifications will not retroactively reduce the Total Credit value or shorten the 12-month redemption period for Gift Cards already issued.

12. Privacy & Communications

Information collected during purchase (Purchaser names, email, phone, billing details) is used to process the order, deliver the Gift Card, manage Aesthetic Record accounts, and provide customer support. We do not sell personal information to third parties.

By purchasing or redeeming a Gift Card, the Purchaser may receive transactional communications related to the order. Marketing communications are sent only to individuals who have separately opted in. Holders may opt out of marketing at any time by following the unsubscribe instructions in any marketing message or by contacting support@estheticfinesse.com.

13. Governing Law & Disputes

These Terms are governed by the laws of the State of Arizona, without regard to conflict-of-law principles.

Any dispute arising out of or relating to these Terms or the Gift Card shall first be addressed informally by contacting Esthetic Finesse at support@estheticfinesse.com or +1 480-908-9695. Esthetic Finesse will work in good faith to resolve disputes within 30 days.

Where informal resolution is not achieved, disputes shall be brought in the state or federal courts located in Maricopa County, Arizona, and the parties consent to the exclusive jurisdiction of those courts.

14. Severability

If any provision of these Terms is found to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect. The invalid provision shall be modified to the minimum extent necessary to make it enforceable, preserving the original intent.

15. Entire Agreement

These Terms constitute the entire agreement between you and Esthetic Finesse regarding the Mother's Day Gift Card and supersede any prior or contemporaneous communications, representations, or agreements.
