Bottom Line Up Front

KPVM LLC is a faith-driven Virginia limited liability company through which its founders carry out marketplace ministry. We are called and ordained to serve God in the marketplace — publishing, teaching, music, and Kingdom resources — and we operate as a legitimate for-profit business with a Kingdom mission. We do not claim status as a church and do not seek church tax exemption. Our calling is to minister in the marketplace, and our business structure is the lawful vehicle through which we do it.

Position

1. We Are Ministers Called to the Marketplace

Marketplace ministry is the conviction that the call of God is not confined to a pulpit or a building. The marketplace — commerce, media, publishing, the arts, and the daily places where people live and work — is itself a field of ministry. KPVM LLC exists so that its founders can fulfill that calling: bringing the message and values of the Kingdom of God into the marketplace through the work of their hands.

2. Our Work Is Kingdom Work

Through KPVM LLC we produce and distribute Kingdom-centered resources, including:

- Courses, blog content, and discipleship tools that equip believers and advance Kingdom understanding.

This structure provides liability protection, a clear governance framework, and the legitimacy to bank, contract, publish, and transact in the ordinary course of business. We meet our obligations to the Commonwealth and to federal authorities as a for-profit entity.

5. We Are Honest About What We Are

KPVM LLC is a for-profit company, not a tax-exempt church or charity. Contributions and purchases are not tax-deductible charitable gifts, and we make no such representation. We believe integrity in how we describe ourselves is itself a Kingdom value. We are ministers doing business in the marketplace for the glory of God — and we say so plainly.

6. Faith and Enterprise Are Not in Conflict

Scripture is full of those who served God through their trade and their substance — builders, merchants, tentmakers, and stewards. We stand in that tradition. Operating a profitable, well-run business is not a compromise of ministry; it is a means of ministry, providing the resources to create, give, and extend Kingdom impact without dependence on outside systems.
