PURPOSE OF THIS PRIVACY POLICY

This Privacy Policy explains how we collect, use, disclose, and protect information when you visit our Website, submit a funding application, request information, engage our commercial funding services, communicate with us electronically, verbally, or in writing. Because we operate in the commercial funding industry, we may collect sensitive business and financial information. We take reasonable steps to safeguard that information.

INFORMATION WE COLLECT

We collect information directly from you, automatically through our Website, and from third parties.

Information You Provide Directly

When you apply for funding or contact us, we may collect business information including, legal business name, DBA name, business address, entity type, EIN, industry, revenue information, time in business, bank account details, merchant processing statements, financial statements. Owner / Guarantor information may include full name, home address, phone number, email address, date of birth, social security number (if required by lenders), ownership percentage. Funding Information may include desired funding amount, purpose of funds, existing debts or obligations.

Information Collected Automatically

When you visit our Website, we may collect IP address, device type, browser type, operating system, pages visited, time spent on pages, referral source, cookies and tracking technologies.

Information From Third Parties

We may obtain information from business credit bureaus, consumer credit bureaus (where permitted), banking verification services, funding partners, marketing platforms.

HOW WE USE YOUR INFORMATION

We use collected information to evaluate funding eligibility, match you with appropriate lenders, package and present funding applications, verify identity and prevent fraud, communicate regarding funding opportunities, improve our Website and services, comply with legal and regulatory requirements We do not use your information for consumer lending decisions.

CREDIT AUTHORIZATION

By submitting a funding application, you authorize the Company and its funding partners to obtain business credit reports, consumer credit reports for owners/guarantors (where applicable), bank account verification reports, and merchant processing verification. Credit inquiries may be soft or hard pulls depending on lender requirements.

HOW WE SHARE INFORMATION

We may share your information with funding partners and lenders to evaluate funding eligibility and provide offers; Service providers including CRM providers, document storage providers, payment processors, identity verification services, IT support vendors; Legal and Regulatory authorities if required by law, subpoena, or regulatory investigation; Business Transfers in connection with a merger, acquisition, or sale of assets. We do not sell personal information in the traditional consumer marketing sense. However, sharing application data with lenders for funding evaluation may be considered a “sale” under certain state laws. See Section 10 for state-specific rights.

DATA SECURITY

We implement reasonable administrative, technical, and physical safeguards to protect your information, including: encrypted data transmission (SSL), restricted access to sensitive data, secure third-party platforms, Internal confidentiality policies. However, no method of transmission over the internet is 100% secure. We cannot guarantee absolute security.

DATA RETENTION

We retain information as long as necessary to provide services as required by lender agreements, to comply with legal obligations, to resolve disputes, to enforce agreements. Retention periods vary depending on the type of information and regulatory requirements.

COOKIES & TRACKING TECHNOLOGIES

Our Website may use cookies, web beacons, analytics tools (e.g., Google Analytics), advertising pixels. These technologies help us understand user behavior, improve marketing

performance, and optimize user experience. You may disable cookies in your browser settings, though doing so may limit Website functionality.

Our Website may contain links to third-party websites. We are not responsible for the privacy practices or content of those websites. Users should review the privacy policies of any external sites.
