

**Liability Release and Hold Harmless Agreement**

**IMPORTANT: BY SIGNING THIS AGREEMENT, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF INJURY, DEATH, OR PROPERTY DAMAGE, ARISING OUT OF YOUR OR YOUR CHILD'S PRESENCE AND/OR PARTICIPATION IN EQUINE ACTIVITIES AT SIMPLY EQUINE, LLC AT SPRING FARM STABLES, INCLUDING INJURY, DEATH, OR PROPERTY DAMAGE ARISING OUT OF THE NEGLIGENCE OF SIMPLY EQUINE, LLC. READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. YOUR SIGNATURE INDICATES YOUR UNDERSTANDING OF AND AGREEMENT TO ITS TERMS.**

Helmets and Safety Gear: I understand that Simply Equine, LLC at Spring Farm Stables recommends wearing an ASTM-approved riding helmet and utilizing other safety gear appropriate to my level of experience while on a horse. I accept full responsibility for accidents or injuries to myself, family members, guests, and others if I or they choose not to use a riding helmet or other appropriate safety gear.

Horses are Inherently Dangerous: I understand that engaging in equine activities is inherently dangerous, and by participating, I expose myself to dangers both known and unknown. Horses are large, unpredictable animals which may be dangerous no matter their training or my level of experience. I shall release and hold harmless Simply Equine, LLC at Spring Farm Stables from any injury arising out of or related to equine activities at the facility.

Hold Harmless, Defend and Indemnify: I agree to defend, indemnify, save, and hold harmless Simply Equine, LLC at Spring Farm Stables, its principals, agents, and affiliates from any loss, liability, damage, attorney's fees, or costs arising out of or in connection with my use of the stable, my presence at the facility, my horse's conduct, my use or access to my horse, or my or my agents' actions or omissions related to this agreement.

Costs, Attorneys' Fees, and Expense: In any legal actions brought in connection with this agreement or arising out of any activity of the horse, myself, or my guests or agents, the prevailing party will be entitled to prompt payment of expenses from the other party following final adjudication in favor of the prevailing party. "Expenses" include attorneys' fees, retainers, court costs, transcript costs, fees of experts, witness fees, travel expenses, duplicating or copying costs, printing and binding costs, telephone charges, postage, delivery service fees, canceled lessons, and all other disbursements.
