All service timelines begin **after onboarding and receipt of required project materials from the client.**

## 4. Project Onboarding

Before work begins, clients must participate in an onboarding meeting where project scope, materials, and expectations are confirmed.

Production begins only after:

- client confirmation of service scope
  - payment activation
