



AFFILIATE POLICIES & PROCEDURES

Affiliate Enrollment

- 1.1 Affiliates will pay a one-time \$40 Affiliate Registration Fee to become a MindTrainer PRO™ Affiliate OR purchase the 'All Access' Subscription which includes the one-time \$40 Affiliate Registration Fee.
- 1.2 Once an Affiliate, they will receive access to their unique affiliate links and tracking tools.

2. Commission Structure

2.1 Two-Tier Commission Plan:

- Tier 1: Earn 33% recurring commission on direct referrals' paid subscriptions.
- Tier 2: Earn 11% recurring commission on subscriptions sold by affiliates you refer.

Note; In order to unlock the 11% second tier commission, the Affiliate must purchase and maintain an active paid account of at least one System (\$14.97/month)

2. Commission Structure (continued)

2.2 Commission applies to the following subscription plans:

- \$14.97/month plan
- \$97/month plan
- \$397/year plan (one-time commission)
- \$4,997 lifetime plan (one-time commission)

2.3 Affiliates are also eligible to earn a one-time \$20 bonus for each referred Affiliate who pays the \$40 Affiliate Registration Fee.

3. Cookie Tracking & Attribution

3.1 Affiliates are credited for sales made within one year (365 days) of a prospect clicking their Affiliate link. If the prospect registers on the account (completes the information on a landing page lead magnet), the Affiliate is tied to that prospect for life, as long as the prospect doesn't enroll with another email address with another Affiliate.

3.2 The last referring Affiliate receives credit for the sale.

4. Payment Terms

4.1 Commissions are paid on a monthly basis, provided the minimum payout threshold of \$20 is met.

4.2 Payments are issued via PayPal.

4.3 Refunds or chargebacks on referred sales will result in commission reversals.

4.4 The Company may modify commission structures, tracking, or terms with a 30-day notice.

5. Affiliate Responsibilities

5.1 Affiliates may use approved marketing materials provided by the Company.

5.2 Affiliates may not engage in misleading, deceptive, or unethical advertising, including spam, false claims, medical claims or bidding/using the Company's brand name (Morry Method, MTP, MindTrainer PRO™, MINDTRAINER or any typo related versions in paid ads or domain names).

5. Affiliate Responsibilities (continued)

5.3 Affiliates must comply with all applicable laws and regulations. No paid search advertising permitted. Example: Google Ads, Youtube Ads, Bing Ads etc. Social Media Ads are permitted (Facebook, TikTok, Instagram, boosted posts etc.).

6. Termination & Modifications

6.1 The Company reserves the right to terminate an Affiliate for violation of this Agreement.

7. Limitation of Liability

7.1 The Company is not liable for indirect damages, lost profits, or technical failures affecting tracking and payments.
