### **California Consumer Privacy Act If Applicable**

California Consumer Privacy Act (CCPA) Privacy Notice. This Privacy Notice applies to California consumers and is a supplement of the GOL Privacy Statement. Private Information Collected. GOL collect information that identifies, relates to, describes, or could reasonably be linked, directly or indirectly, with a particular consumer or household (“CCPA private information”). GOL have collected the following categories of CCPA private information from consumers within the last twelve (12) months:

**Identifiers:** “Identifiers” covers a broad range of information, such as things like name, email address, billing address, and IP address. We collect private information that falls into this category. For example, for Visitors and/or Members GOL have an email address and payment information (such as a credit card).
