1. PARTIES

Service Provider: Raven Van Asten, doing business as Kumi Collective ("Kumi Collective," "Provider," or "we"), a virtual coaching and training organization operated in the State of California.

Client: The individual or organization identified on the signature page below ("Client" or "you").

This Agreement governs Client's enrollment in and participation in the Kumi Collective Kingdom Neuro-Coaching Foundations 12-Week Training and Certification program (the "Program").

2. PROGRAM DESCRIPTION

- Testing and certification assessment
- Certificate of Completion upon passing the certification assessment
- Access to a private Voxer community group for peer support and bonus Q&A

4.3 Payment Method

4.4 Late Payments

If Client is on a payment plan and fails to remit a scheduled payment within seven (7) calendar days of its due date, Provider reserves the right to suspend Client's access to Program materials until payment is received. Failure to cure a missed payment within thirty (30) calendar days may result in termination of enrollment without refund of amounts paid.

5. REFUND AND CANCELLATION POLICY

5.1 Cancellation by Client Before Program Start

- Cancellation received in writing on or before September 2, 2026: Client receives a full refund of all amounts paid, less a \$150.00 administrative processing fee.
- No refund will be issued for cancellations received after September 3, 2026 (the date of Session 1).

5.3 Cancellation by Provider

If Provider cancels the Program prior to commencement, Client will receive a full refund of all amounts paid. If Provider cancels after commencement due to circumstances beyond Provider's reasonable control, Provider will issue a pro-rated refund based on sessions not yet delivered, or offer a credit toward a future program cohort at Client's election.

7. CLIENT RESPONSIBILITIES

Client agrees to:

- Provide accurate contact and billing information at enrollment
- Maintain a reliable internet connection and appropriate technology to access Zoom and digital learning materials
- Dedicate approximately 20–40 minutes per week to pre-class self-paced content in addition to live lab sessions
- Treat fellow participants and Provider with respect in all community interactions
- Maintain confidentiality regarding personal information shared by other participants in the Voxer community and live sessions
- Comply with all applicable laws in connection with Client's use of Program content

8. INTELLECTUAL PROPERTY

All Program materials, course content, recordings, frameworks, workbooks, templates, and other resources provided by Kumi Collective are the exclusive intellectual property of Raven Van Asten / Kumi Collective and are protected by applicable copyright and intellectual property laws.

Client is granted a limited, non-exclusive, non-transferable license to use Program materials for Client's own personal and professional use (including use with Client's own clients, ministry, or organization). Client may not:

- Reproduce, distribute, resell, or publicly share Program materials without prior written consent from Provider

9. CONFIDENTIALITY

Client acknowledges that other participants may share personal, professional, and spiritual information during live sessions and in the Voxer community. Client agrees to hold all such information in strict confidence and not to disclose it to any third party without the express consent of the disclosing participant.

10. LIMITATION OF LIABILITY

To the maximum extent permitted by applicable law, provider's total liability to client for any claim arising out of or related to this agreement or the program shall not exceed the total tuition amounts actually paid by client to provider. In no event shall provider be liable for any indirect, consequential, incidental, special, or punitive damages, regardless of the cause of action or the theory of liability.

11. INDEMNIFICATION

Client agrees to indemnify, defend, and hold harmless Raven Van Asten, Kumi Collective, and their affiliates, agents, and representatives from and against any claims, damages, losses, or expenses (including reasonable attorneys' fees) arising out of or related to: (a) Client's breach of this Agreement; (b) Client's use of Program materials in a manner not permitted by this Agreement; or (c) Client's own coaching or ministry activities conducted with third parties.

The parties agree to attempt to resolve any dispute informally before pursuing formal remedies. Client shall notify Provider in writing of the nature of the dispute, and the parties shall confer in good faith for at least fifteen (15) calendar days.

12.2 Binding Arbitration

If the dispute is not resolved informally, it shall be submitted to binding arbitration administered by JAMS (or a mutually agreed arbitration provider) in accordance with its applicable rules. The arbitration shall be conducted in the State of California. Judgment on the arbitration award may be entered in any court of competent jurisdiction. Notwithstanding the foregoing, either party may seek injunctive or other equitable relief in a court of competent jurisdiction to prevent irreparable harm.

12.3 Class Action Waiver

Client waives any right to participate in a class action lawsuit or class-wide arbitration against Provider.

13. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the State of California, without regard to its conflict-of-law provisions.

14. ENTIRE AGREEMENT; AMENDMENTS

This Agreement constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior discussions, representations, or agreements. This Agreement may be modified only by a written amendment signed by both parties. Provider's program brochure, marketing materials, and FAQs are for informational purposes and are incorporated herein by reference only to the extent not inconsistent with this Agreement.
