



## SCALEIFY AFFILIATE AGREEMENT PLAIN LANGUAGE SUMMARY

***This is not a legal document, it is a plain English summary of the Affiliate Agreement that you signed.  
The full agreement governs all terms are contained in your assigned agreement***

### Getting In

Once you get a confirmation email — you're in. We reserve the right to manually review every application. If manual review is required, please allow up to seven (7) days. Any referrals you send before that confirmation don't count toward commissions, so wait for the green light before you start sharing.

### What We Expect From You

Be honest. Don't spam people. Don't make promises we didn't authorize. If you promote Scaleify — via a social post, or an ad — you need to disclose that you're an affiliate. That's an FTC requirement and a condition of staying in the program.

**How You Get Paid** You earn 30% of the setup fee when your referred client makes their first payment. You also earn 30% of their monthly fee every single month they stay active. Here's what that looks like across our tiers:

## SCALEIFY AFFILIATE AGREEMENT PLAIN LANGUAGE SUMMARY

### IMPORTANT

- **Setup fees can change. Sometimes we waive or discount the setup fee to close a deal. If that happens your setup commission adjusts to match — or goes to zero if the fee is fully waived. Your monthly recurring commission is never affected.**
- **Processing fees come out first. Commissions are calculated on what we actually receive after payment processing fees (typically 2.9% + \$0.30 per transaction). The exact amount will show in your dashboard at payout time.**
- **Commissions are paid on the 17th of each month via Zelle, Cash App, Venmo, or check.**
- **If a client upgrades to a higher tier, your monthly commission moves up with them.**

**What Counts as a Qualified Referral** A referral is official when your client has signed an agreement AND made their first payment. A signed agreement with no payment doesn't trigger a commission.

**Your Referral Link** You'll get a unique link when you're accepted. Every referral needs to go through that link — we can't track or pay commissions without it. Keep it secure. Don't post it publicly in places where random people could click it without your involvement.

Attribution works on a first-touch basis — whoever's link a prospect clicks first gets the credit. Your referral is valid for 90 days from the first click. If they don't sign up within 90 days the referral expires.

**Refunds & Chargebacks** If a client gets a refund or disputes a charge, we'll deduct the corresponding commission from your next payout. We'll always notify you in writing within 10 days and tell you exactly which client and transaction it relates to. Deductions won't exceed what you earned on that specific transaction.

**If We Part Ways** You can leave anytime — just send us an email. We can also end the agreement immediately if you violate the terms. Either way, any commissions you've already earned up to that point will be paid out on the next 17th. After the termination date, no new commissions are earned — even on clients you originally referred.

**Your Privacy Obligations** Anything we share with you about our pricing, clients, or business operations stays between us. Don't share it with anyone without our written permission.

**Non-Compete** While you're in the program and for 12 months after you leave, we ask that you don't actively promote competing AI voice, chat, or business automation services.

**If We Change the Terms** We'll email you at least 30 days before any changes take effect. If you don't agree, you can opt out before the effective date and we'll pay out whatever you've earned. If you keep participating after the change date, that means you accept the new terms.

**If There's a Dispute** Let's talk first. Send us an email at [support@getscaleify.io](mailto:support@getscaleify.io) and we'll respond within 10 business days. If we can't resolve it within 30 days, the matter goes to binding arbitration in Atlanta, Georgia. Both parties cover their own costs.
