COMMUNITY PARTICIPATION IN THE DESIGN PROCESS WILL ENSURE THAT UNIQUENESS. EVEN AS WE WORK TOWARD FULFILLING THIS VISION, THE FRIENDS OF THE LOWLINE CONTINUE TO PROMOTE AFFORDABLE WORKFORCE HOUSING, AND TOWARD PROTECTING HOMEOWNERS AND RENTERS BY PRESSING TO FIND WAYS THEY CAN REMAIN IN THEIR HOMES AND KEEP THEIR NEIGHBORHOODS AS THEIR OWN.
