What You Know Is Worth More Than What You Do

Transaction Model

Advisory Model

An attorney struggling to scale would pay you \$10K to learn how you built a practice that works.

They use those systems for years. They refer others. It compounds.

Same expertise. Completely different leverage.

You've been monetizing it the hard way.

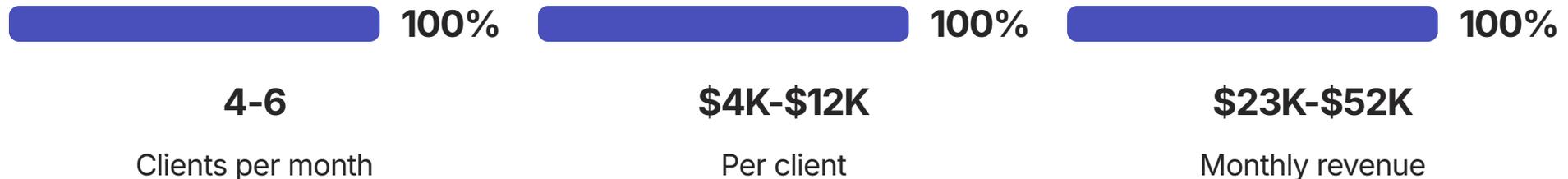
The Shift That's Happening Right Now

They're closing 4-6 clients per month at \$4K-\$12K each.

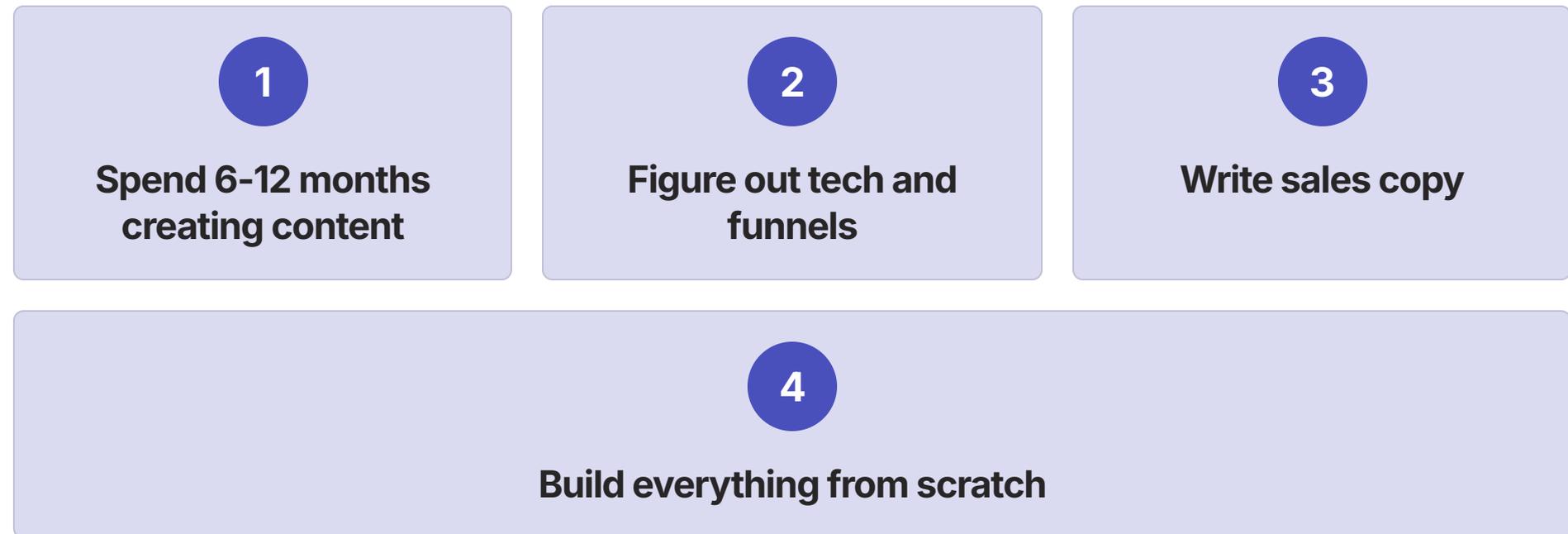
\$23K-\$52K/month. No billable hours. No malpractice risk.

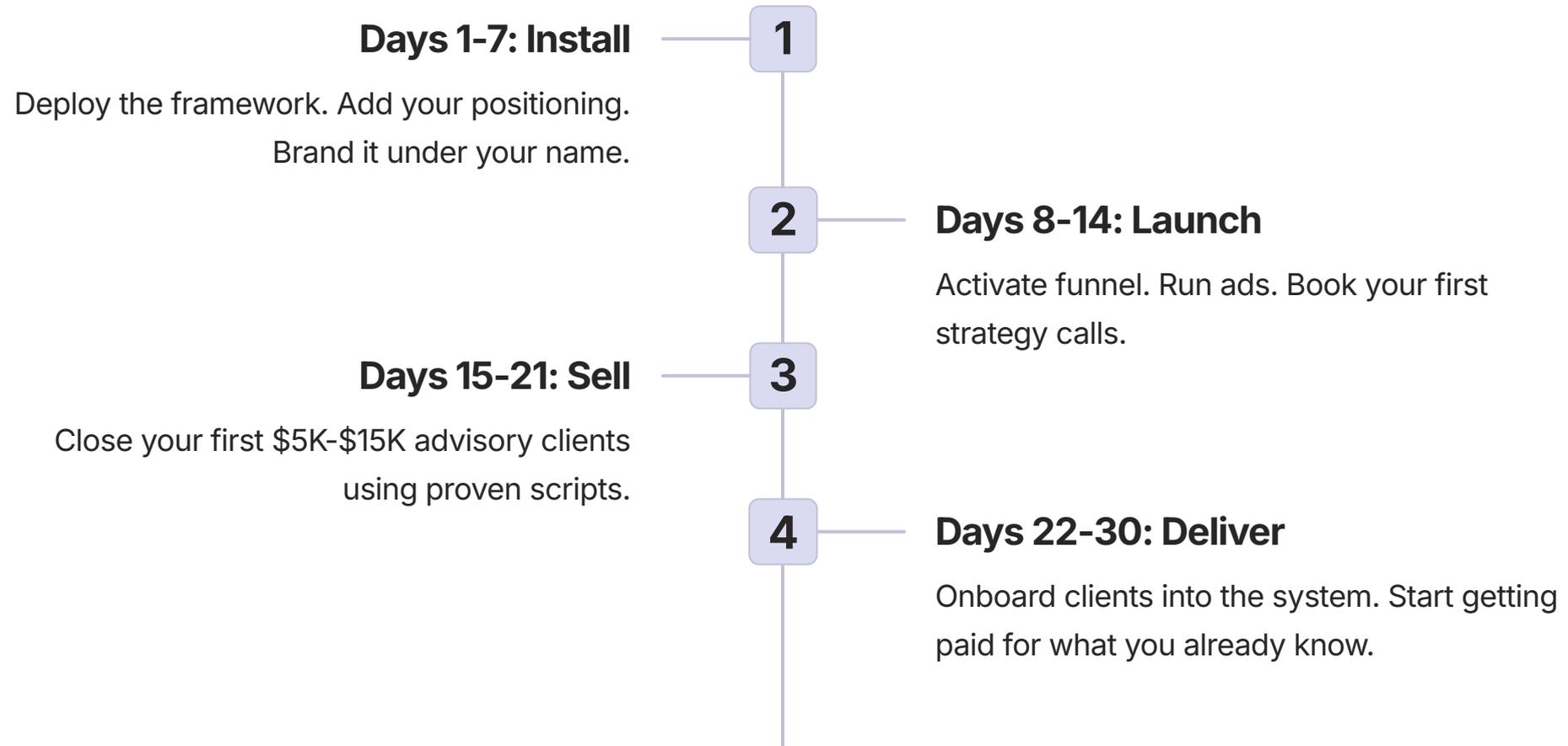

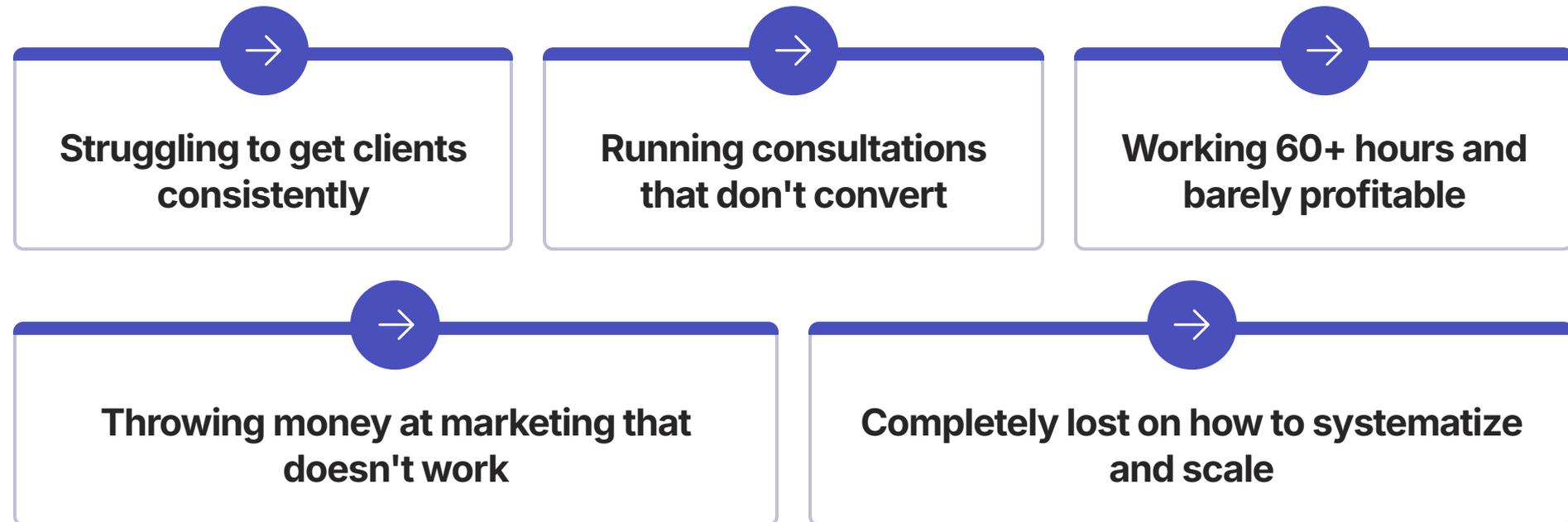

Why Attorneys Will Pay You \$10K+
