

Privacy Policy — Thrive Together Network

What we collect • Contact details you provide: name, email, phone. • Optional details: location, preferences, notes you choose to share. • Technical data: IP address, device/browser info, and cookies or similar tech. • Interaction data: email/SMS opens, clicks, and form submissions.

How we use your data • To manage the Early Interest Waitlist, respond to inquiries, and deliver requested information. • To send updates about cohorts, events, and offers if you opt in. • To improve our services, website experience, and communications. • To meet legal, tax, and compliance obligations.

Legal bases for processing (EU/UK) • Consent when you opt in to emails/SMS. • Legitimate interests for site security, analytics, and improving services. • Contract when you register for programs you purchase. • Legal obligation where records must be retained.

Sharing your data • We do not sell your personal information. We share it only with trusted service providers who help us operate our business (email/CRM platforms, scheduling, payment processors, website hosting). They are bound by contract to protect your data and use it only for our instructions. • If required by law or to protect our rights or safety.

International transfers • We are based in Canada and operate online. Your data may be processed in other countries where our providers operate. We use safeguards such as contractual protections for international transfers where required.

Retention • We keep personal data only as long as needed for the purposes above, then delete or anonymize it per our retention schedule and legal requirements.
