**AGREED ORDER GRANTING PLAINTIFF'S MOTION FOR LIMITED EXTENSION OF
NOTICE MAILING DEADLINE AND OPT-OUT DEADLINE**

Upon consideration of Plaintiff's Motion for Limited Extension of Notice Mailing Deadline and Opt-Out Deadline, the agreement of the parties, the record in this matter, and for good cause shown, the Court finds that the requested relief is limited, practical, and appropriate to preserve the notice program previously approved by the Court while maintaining the existing Final Approval Hearing date and related schedule.

Accordingly, it is hereby **ORDERED** as follows:

1. Plaintiff's Motion for Limited Extension of Notice Mailing Deadline and Opt-Out Deadline is **GRANTED**.
2. The deadline for the Settlement Administrator to mail Notice to the Settlement Class is extended from June 25, 2026 to **July 10, 2026**.
3. The deadline for Settlement Class Members to request exclusion from the Settlement Class is set for **September 7, 2026**.
4. The Final Approval Hearing shall remain scheduled for **September 23, 2026 at 10:00 a.m.**
5. The Objection Deadline shall remain **August 26, 2026**.
6. The deadline for filing the Motion for Final Approval, Class Counsel's Fee Application, and any request for a service award shall remain **August 14, 2026**.

7. Except as expressly modified by this Order, all deadlines, findings, directives, and provisions of the Court's May 26, 2026 Agreed Order on Unopposed Motion for Preliminary Approval of Class Action Settlement and Scheduling Order remain unchanged and in full force and effect.

The Clerk is directed to enter this Order and provide notice to all counsel of record.
