



THRIVE BEYOND CANCER FORMULA PARTICIPATION AGREEMENT

By signing where indicated below, you irrevocably agree that if Season Johnson [aka. Moment Chaser, LLC.] operating as Thrive Beyond Cancer Formula approves your application and accepts you as a Thrive Beyond Cancer Formula™ membership participant, this agreement automatically becomes a binding contract you and the Company, and applies to your participation. By signing below, you are acknowledging that you have read, agree to and accept all of the terms and conditions contained in this Agreement. We reserve the right to amend this Agreement at any time by sending you a revised version at the address you provided.

The investment to take part in the membership is the following:

Step #1: 1 non-refundable payment of \$1200 for access to the Thrive Beyond Cancer Program. Access starts the date of payment. This \$1200 payment is waived for any member that has been in our Thrive Through Cancer Formula membership for at least 3 months and is rolling into this program within 30 days of their membership ending with TTCF.

Step #2: Monthly payments of \$99 per month as long as you would like to have full access to the program. If you choose to stop your monthly payments and withdraw from the program, you will be charged the \$1200 start up fee to join again in the future.

By completing the agreement and signing below, you authorize the Company to charge your credit card, as indicated, as payment for your membership with Thrive Beyond Cancer Formula and its entirety. Furthermore, you agree that you are responsible for full payment of fees for the entire course of your membership, regardless of whether you actually attend or complete the Program, and regardless of whether you have selected a lump sum or monthly payment plan. To further clarify, NO REFUNDS will be issued and all monthly payments must be paid on a timely basis.
