## Partnership Agreement

2. I (We) understand that Legacy is not a school and cannot be listed as the "school of record" with the local state department of education, Secretary of State or on high school transcripts. I (We) am(are) responsible for familiarizing myself(ourselves) with the state's homeschooling requirements.
3. I (We) understand that I (we) am (are) the primary teacher(s) of my (our) child(ren). I (We) am (are) committed to hold my (our) student(s) accountable and will ensure that my (our) child completes weekly assignments to the best of his or her ability and as directed by me (us). I (We) will inform Legacy Leaders of any adjustments to the work I (we) require that varies from the weekly assignments, understanding my (our) student(s) is (are) expected to participate in class weekly.
4. I (We) understand that as the parent(s) of our students, I will remain on campus during the designated weekly community gathering. Should an emergency arise, I am to authorize another parent to be responsible for my child(ren), informing and making arrangements with Legacy's Director.
5. I (We) will assume full responsibility for any accident/medical insurance needed to cover my (our) child(ren) in the case of accidental injury, or the like, while my (our) child(ren) is (are) attending Legacy Christian Homeschool Fellowship. I (We) will not hold Legacy Christian Homeschool Fellowship, its host church, or anyone in leadership responsible in any manner for injury.

## Tuition

- Family Enrollment Fee \$200
- Half Day, K-3<sup>rd</sup> \$675, \$75/mo
- K-6<sup>th</sup> (full day) \$1,080, \$120/mo
- Jr High / High School \$1,620, \$180/mo

-Tuition includes facility fee, community-day supplies, insurance, and teaching fees.  
-5% discount provided for prepaying the tuition before the school year with a check.

\*Books are the responsibility of the parent. No substitutions are allowed for grammar and composition in 4<sup>th</sup>-6<sup>th</sup> grade, or any substitutions in 7<sup>th</sup> - 12<sup>th</sup> grade.

### Payment Terms:

1. **Enrollment Fee** - Due at the time of enrollment. Non-refundable.
2. **Tuition** - May be paid monthly or in full.
  - a. Tuition will be collected September 1<sup>st</sup> - May 1<sup>st</sup> (9 months)
  - b. Payments will be set up to be withdrawn automatically on the 1<sup>st</sup> of each month.
  - c. A 5% discount is issued if annual tuition is pre-paid in full with a check by August 1<sup>st</sup>.
3. **Late Fees** - In the event of insufficient funds, a late fee of \$30 will incur and your child/ren will not be able to attend community until tuition is made current.
4. **Refunds** - full refunds will not be issued for any reason. In the event your family must exit the program, no further tuition will be collected. If paid in full, a prorated amount will be refunded for the remaining months minus the initial 5% discount and the enrollment fee.
