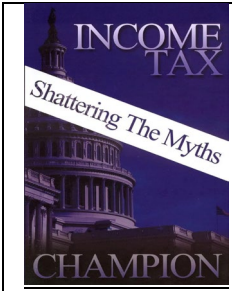

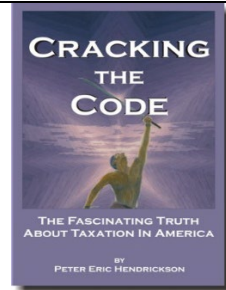

Do you have tax burdens, and personal liability?

When you put assets in your name, you also carry the liability. And by setting up a corporation, LLC, or partnership .. you also carry the liability for the share of ownership you have in these organizations. When you receive a W-2 form, 1099, or K-1 at the end of each year - that shows your liability for the assets you have carried in your name, or your business name. Did you know that it is the using of your social security number that creates tax liability? Since the Social Security Act of 1935, unique identifiers (fictional 9-digit numbers) are assigned shortly after birth to each baby born. Without seemingly having a choice in the matter, each person when coming of age and getting a first job (typically the age of 16) part of the process is to give to the employer the 9-digit number assigned to them via an application. The employer has the person sign a contract (a W-4 form) and upon the first paycheck taxes are withheld every week until the end of the year. This withholding of monies earned for the work the employee has done from each paycheck by the employer is done "as a favor" on behalf of the employee so that the person doesn't owe a big tax bill at the end of the year.

What is normally never questioned is the fact that this 16-year-old most likely had never been obligated to have filed a tax return to begin with because (with 98% certainty regarding the general population) he/she was not under the jurisdiction of Washington D.C. to begin with. However, assumptions were made that the person should file a yearly tax return and the amount of the withheld money by the employer throughout the year is mailed to the person by January 31 of the following year. This mailing is a W-2 form and in the form is the amount paid to him/her and the amount withheld. The young ignorant person then hands the form over to an accountant and a 1040 tax return is compiled and signed under penalty of perjury. If the person is "lucky" they receive a "refund" of the amount withheld over the year and are temporarily happy. Is this you? Did you go through this beginning stage of the tax scheme process? This was me also.

Did anybody tell you that there was another option? The other option would have been to never have filed a return and never have any money withheld from your paycheck (given that you are part of the 98% of the general population who is not under the jurisdiction of Washington D.C.). This other option would have you sign that same contract with your first employer (the W-4 form), but letting them know that you are exempt from withholding by writing "EXEMPT" under box 4(c) on the form. You then would have received all your money every paycheck with no withholding. Doesn't that sound a whole lot better?

Well, in comparison to the small amount of money you donated that first year working .. can you imagine the lifetime of donations you may have and still are accumulating, especially if you truly never were obligated to begin with? How shocking this may be for you to read this is the fundamental truth of the passing of the 16th Amendment. You have signed contracts (tax returns) under the penalty of perjury and have agreed to keep filing returns year after year (unless you file a Revocation of Election, which we do assist you in this matter as well).

When your social security number is submitted to the jurisdiction of Washington D.C. you are also assigned the tax liability of payments received. This is true whether you receive payments directly to your SSN or to a business entity established by your SSN such as:

- **A Corporation:** uses your social security number to establish the entity
- **An LLC:** uses your social security number to establish the entity
- **A Partnership:** uses your social security number to establish the entity
- **A Trust:** uses your social security number to establish the entity

BEGIN AN UNINCORPORATED NONPROFIT ASSOCIATION

An Unincorporated Nonprofit Association is a state-registered entity that can hold assets (bank accounts, property, etc). It is as legal of an entity to establish as a corporation or LLC, but with many numerous advantages.

- A UNA is member-based, so nobody owns it, including you. This is a good thing as Rockefeller himself quoted.
- Your social security number is not used in establishing the entity, so it is not tied to your name (or your social security number)
- It has a tax-exempt EIN number assigned to it by the IRS.
- A UNA can receive payments, 1099s.
- A UNA is private and not found when doing an online search. The Secretary of State themselves do not list Associations on their website.

We encourage you to looking into beginning an unincorporated nonprofit association and allow the association to own assets and be free yourself from the burden of personal liability. How will that impact you?
