

Privacy Policy

This Privacy Policy ("Policy") applies to <https://signatureexecutiveservicesllc.com> , and Signature Executive Services LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [insert website here]. The Company's website is a Real Estate Virtual Assistance site. Collection of your Personal Information

Sharing Information with Third Parties

- Comply with an existing legal obligation; or
- Otherwise, use your personal information internally, in a lawful manner that is compatible with the context in which the consumer provided the information.
