EPF (KWSP) EDUCATION WITHDRAWAL GUIDE



WHAT IS EPF EDUCATION WITHDRAWAL?

The EPF Education Withdrawal facility allows EPF (KWSP) members to withdraw savings from Account 2 to finance their children's or their own education at approved local or overseas institutions.

MAHSA International College is an approved institution under KWSP's list, making it possible for parents or students to ease their tuition burden using their EPF savings.

CONDITIONS

Must Be EPF Contributors With Sufficient Funds In Account 2

Must Be An EPF Member Pursuing Diploma And Above Programmes

Allowed With Proof Of Legal Responsibility Or Court Order

Note: Only full-time or part-time studies at MAHSA International College for Diploma level and above are eligible.

APPLICATION PROCESS

STEP 1: PREPARE YOUR DOCUMENTS

- Student's Offer/Confirmation Letter from MAHSA International College
- Official Fee Structure (From MAHSA International College Accounts)
- Student's IC & Parent's IC (Copy)
- EPF Statement (Account 2)
- Bank Account Details (For Refund If Applicable)

STEP 2: WALK IN SUBMISSION

Walk-In:

- Visit Your Nearest EPF (KWSP) Branch With Complete Documents.

APPLICATION PROCESS

STEP 3: GET APPROVAL

- Processing Time: Within 5–10 Working Days
- Notification Will Be Sent Via SMS/Email
- Payment Will Be Credited Directly Into MAHSA International College Bank Account

STEP 4: CONFIRMATION & RECEIPT

- EPF will issue a statement to the applicant
- MAHSA International College Accounts will receive the cheque from EPF and update fee records
- Any balance refund (if applicable) will go to the student's or parent's account
