

Privacy Policy

This Privacy Policy ("Policy") applies to <https://apply.destinyfaithmckoy.com/mom-school-application>, and Mom School ("Company") and governs data collection and usage. For the purposes of this Policy, unless otherwise noted, all references to the Company include <https://apply.destinyfaithmckoy.com/mom-school-application>. The Company website is a This website is used to provide information about the Mom School membership, collect applications, and process payments. Upon joining, members are granted access to a separate private community platform called GoKollab, powered by GoHighLevel, where the membership content, coaching calls, and community interaction take place. Member information including name and email address is shared with GoKollab and GoHighLevel solely for the purpose of providing access to the membership community. site. By using the Company website, you consent to the data practices described in this statement.

I. Collection of Your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Email address

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through the Company's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. The Company may also use your personally identifiable information to inform you of other products or services available from the Company and its affiliates.

III. Sharing Information with Third Parties

The Company does not sell, rent, or lease its customer lists to third parties.

The Company may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (email, name, address, phone number) is not transferred to the third party.

The Company does not sell biometric data to third parties.

X. Data Security and Breach Notification

The Company will provide any required notice in the manner and within the timeframes prescribed by applicable law.
