- The current status certificate, declaration, description, bylaws, rules, budget, insurance and reserve information.
- Every current common expense, resort-club due, capital assessment, inclusion, increase and management arrangement.
- Repair, maintenance, landscaping, snow, parking, utility and insurance responsibilities.
- The resale agreement, title conditions and any current resort-club membership or transfer obligations.
- The entitlement, transfer, duration, access rules and costs attached to golf, ski, beach and other promoted facilities.

Cost categories to separate

Purchase

Confirm price, deposit, financing, legal costs and adjustments.

Ongoing

Confirm common expenses, taxes, utilities, insurance and maintenance.

Future

Review reserve planning, fee changes, resort-club dues and capital assessments.

IMPORTANT

Nearby resort amenities and marketing language are not proof that every feature is included with every unit. Confirm current legal rights, membership terms, dues, assessments and maintenance obligations in the exact status certificate, purchase, title and resort-club documents.
