- Unit boundaries, repair, maintenance, landscaping, snow, roads, utilities, taxes, services and insurance responsibilities.
- The current corporation, management contacts, resale documents, disclosure materials and closing conditions.
- Current access, costs, rules and responsibilities attached to The Shores Club and shared facilities.

Cost categories to separate

Purchase

Confirm price, deposit, financing, legal costs and adjustments.

Ongoing

Confirm common expenses, taxes, utilities, insurance and maintenance.

Future

Review reserve planning, fee changes, assessments and future obligations.
