

## **Privacy Policy**

This Privacy Policy ("Policy") applies to [www.anewdayofclosings.com](http://www.anewdayofclosings.com), and A New Day Of Closings Co., LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [insert website here]. The Company's website is a Real Estate Virtual Assistance site. ### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

### **Sharing Information with Third Parties**

- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise, use your personal information internally, in a lawful manner that is compatible with the context in which the consumer provided the information.
