If you cannot afford an attorney, you may be eligible for free legal services from a nonprofit legal services program. 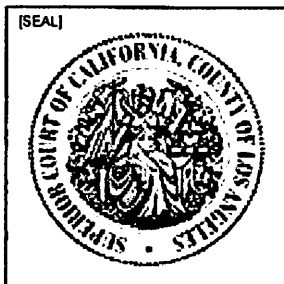
