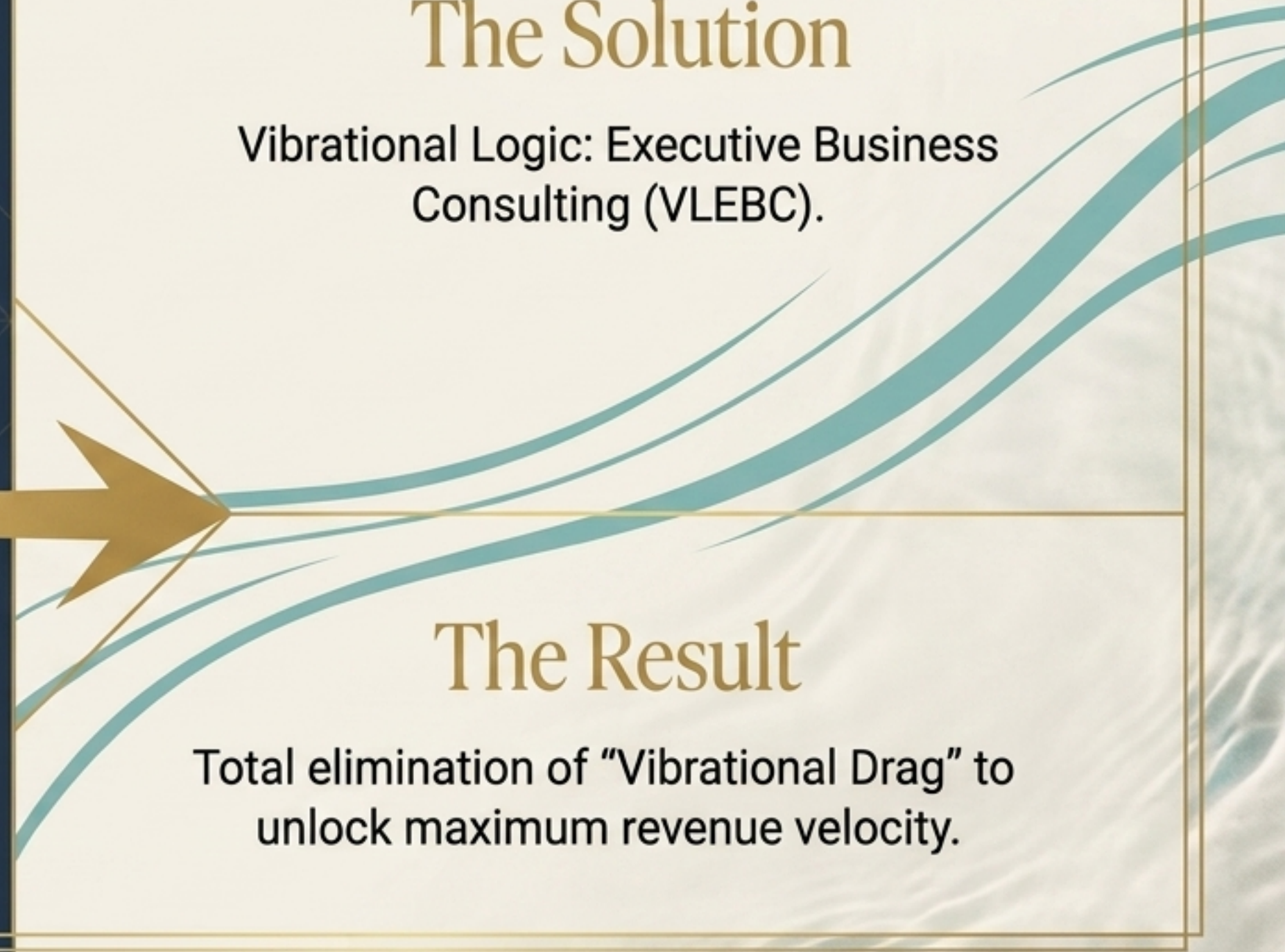

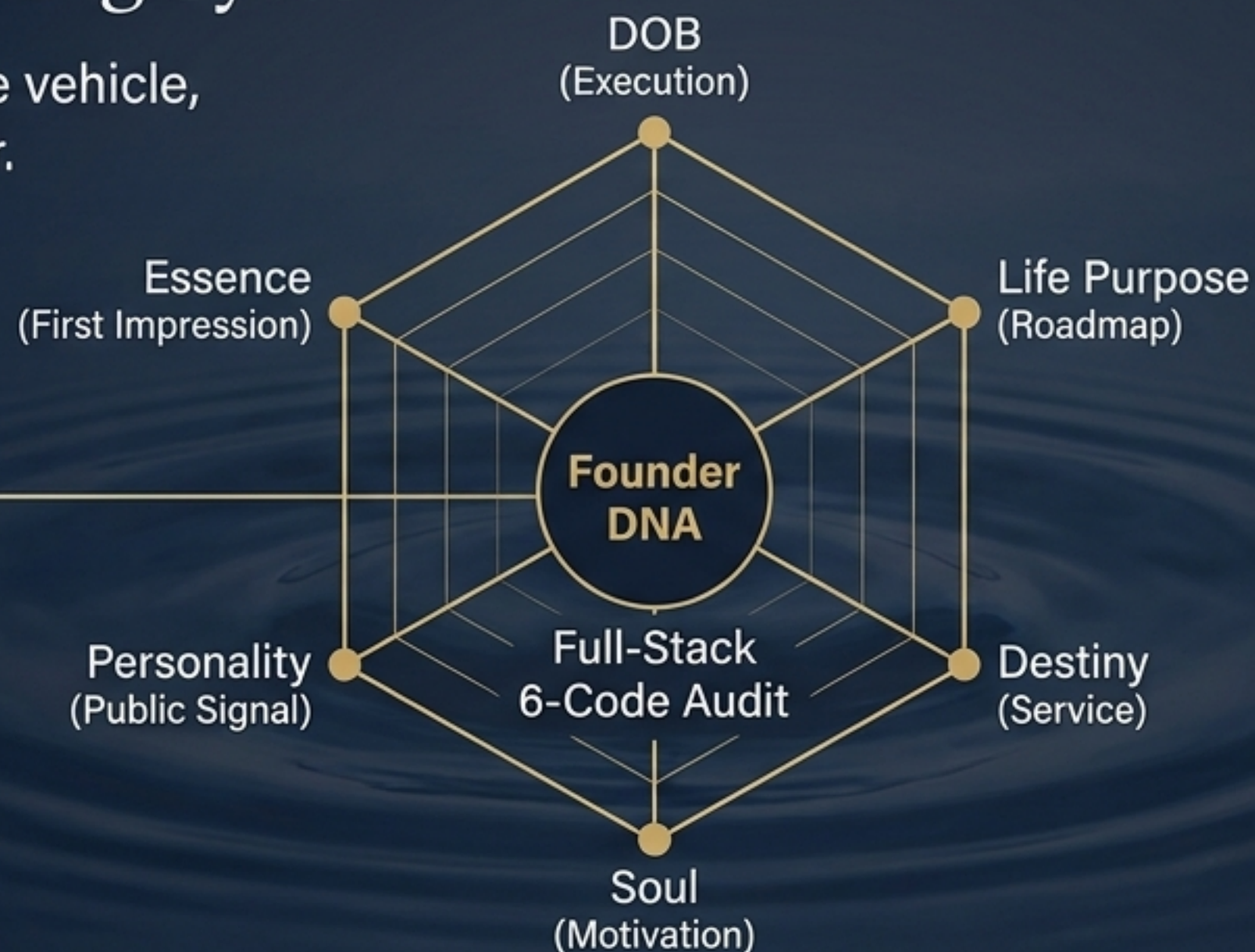
The 4-Phase Forensic Architecture
