## 1. Purpose, identities and separate legal capacities

Performance Financial Consultants Limited receives all commissions, referral fees, revenue-sharing amounts and EMD fees connected with PFC and Adrian C. Spitters business. Adrian C. Spitters does not receive those amounts personally. No payment described here is made to Adrian or Peter personally.

## 2. Who does what

New World Precious Metals governs its own brokerage, pricing, transactions, accounts, custody, storage, delivery, privacy and complaint functions. New World Precious Metals may deal with Questrade or another provider in its own service chain; PFC does not deal directly with Questrade.

## 3. Limits on the referring business

PFC may identify a need, explain a disclosed direct-referral path, obtain consent and make an introduction. PFC does not act as a metals broker, dealer, account provider, custodian, storage provider or delivery provider, does not hold client funds or metals, and does not determine the provider's pricing, execution, custody or delivery terms. This direct channel is separate from any Axxess channel.

## 4. Client decision and documents

A referral or introduction does not require the client to proceed and does not guarantee acceptance, underwriting, account opening, a transaction, coverage, liquidity, value or a particular outcome.
