1. Information We Collect

We only collect the information necessary to deliver our products and communicate with you. This includes:

- **Contact Information:** Your first name and email address when you opt-in to receive a free download, newsletter, or purchase a product.
- **Payment Information:** When you make a purchase, payment is processed securely through Stripe, our third-party payment processor. We do not collect, store, or have access to your credit card number, billing address, or any other sensitive payment details. All payment data is handled directly and exclusively by Stripe in accordance with Payment Card Industry Data Security Standards (PCI-DSS). - **Usage Data:** Basic, anonymized analytics data (such as page views and link clicks) to help us understand how visitors interact with our websites.

2. How We Use Your Information

We use your information exclusively for the following purposes:

- To deliver the digital products (e.g., PDF journals, workbooks) you requested.
- To send you relevant updates, newsletters, and promotional offers related to the specific brand you interacted with.
- To improve our website functionality and user experience.
- We will not use your information for any purpose beyond what is described in this policy without first obtaining your consent.

3. Sharing Your Information

We do not sell, rent, or trade your personal information to third parties under any circumstances. We may share your information only with trusted third-party service providers who assist us in operating our websites and delivering our products. These providers are contractually obligated to keep your information confidential and to use it only for the specific services they provide to us.

Our current third-party service providers include:
