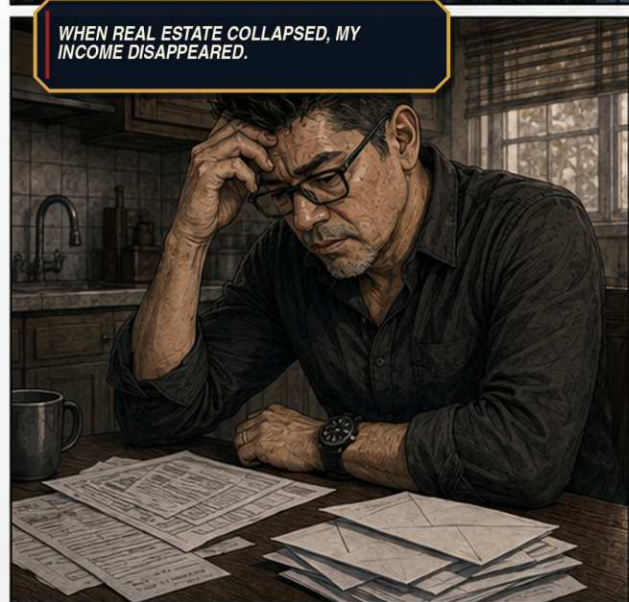

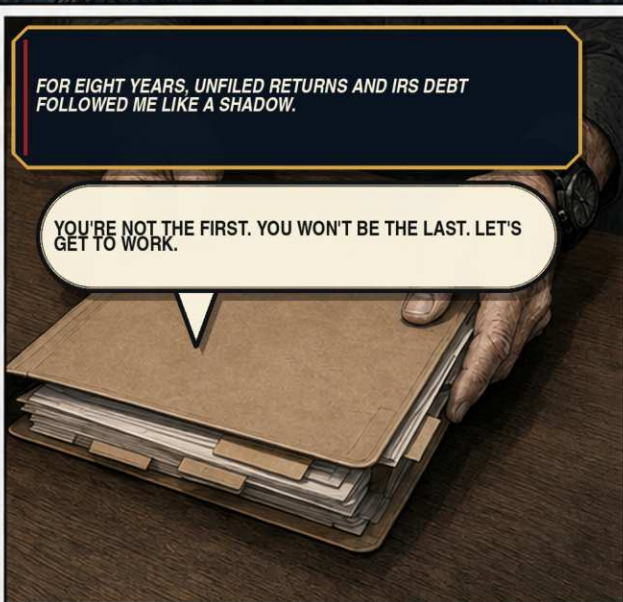

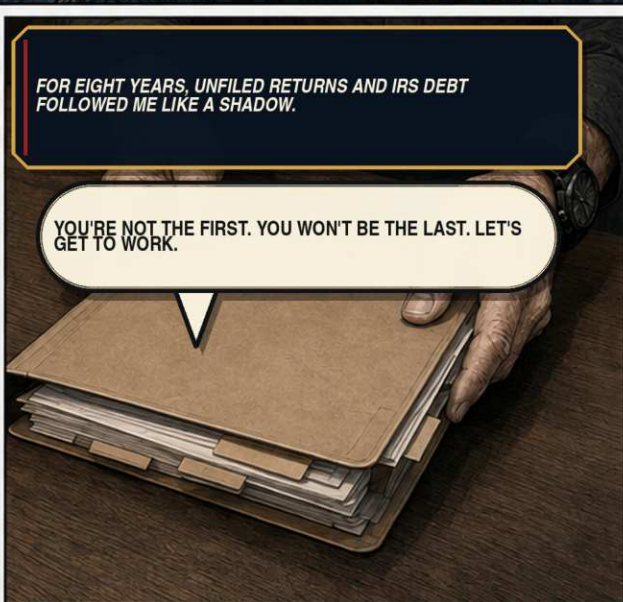
SOME EMERGENCIES CALL BEFORE THE SUN COMES UP.



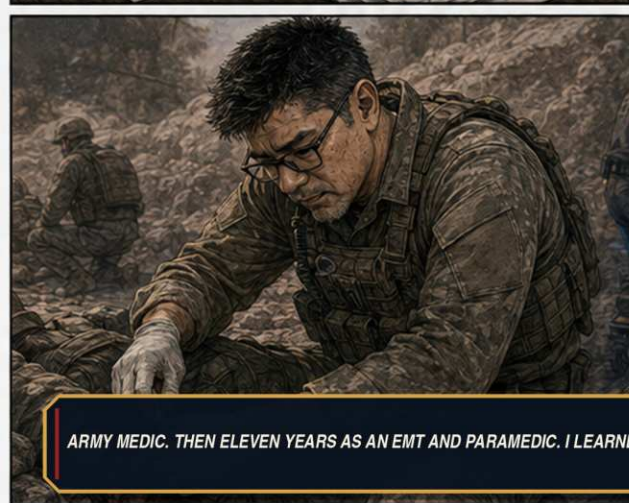
WHEN REAL ESTATE COLLAPSED, MY INCOME DISAPPEARED.

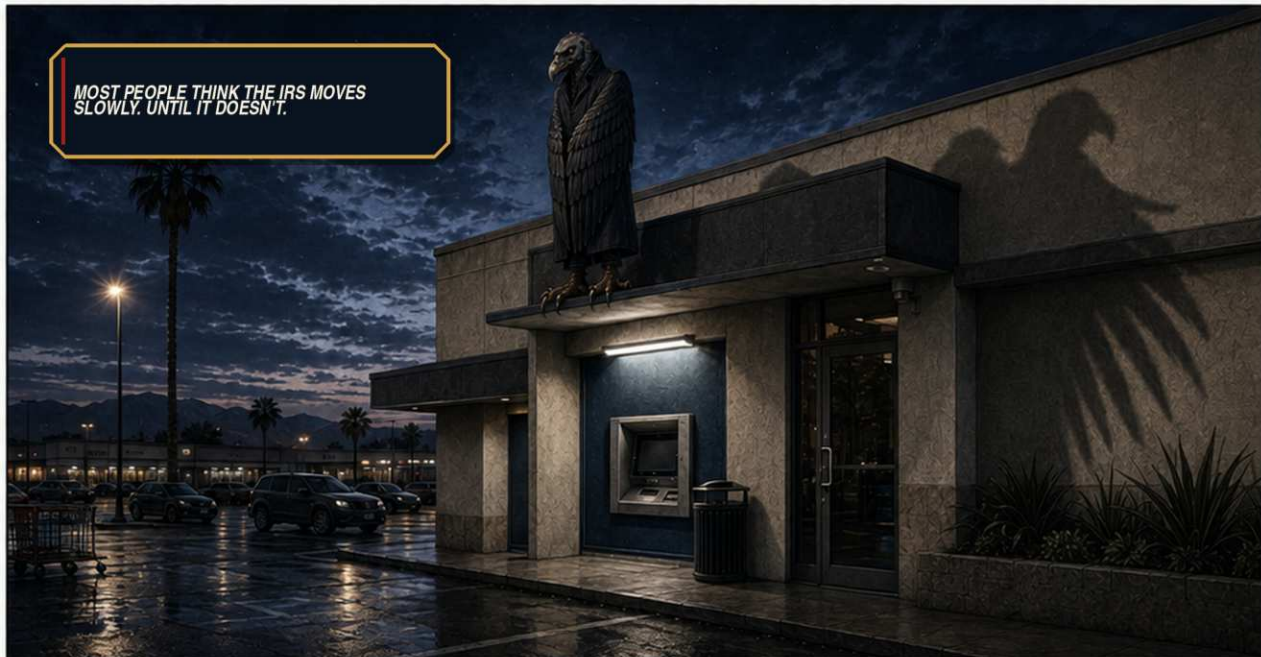

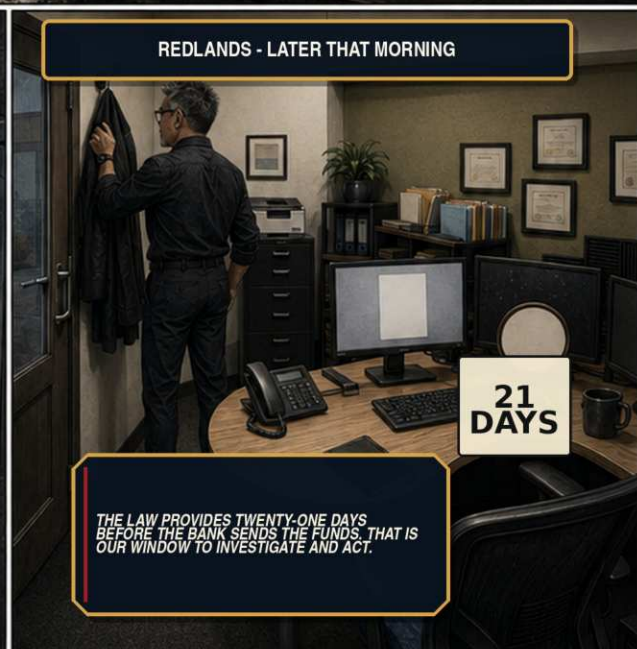
IT FELT SUDDEN. IT WASN'T. THE VULTURE HAD BEEN CIRCLING FOR WEEKS.

TRIAGE: CONFIRM THE LEVY, THE DEADLINE, AND THE DAMAGE.



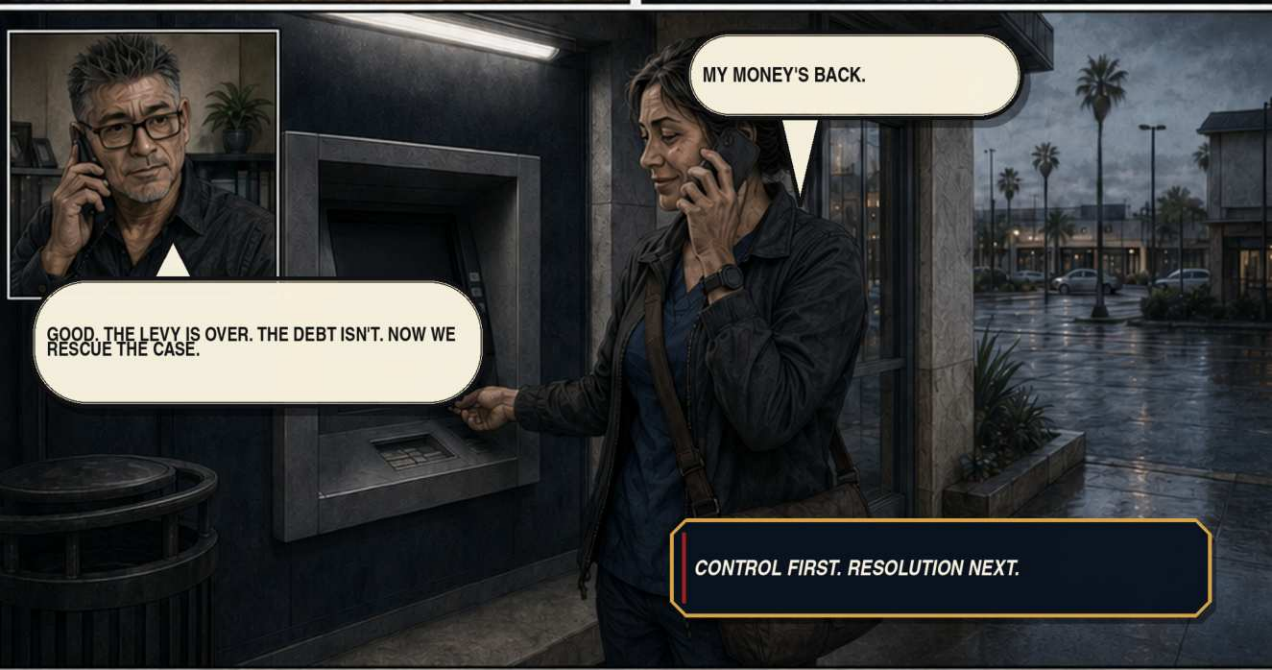
BEFORE THE TWENTY-ONE DAYS EXPIRE

MY MONEY'S BACK.

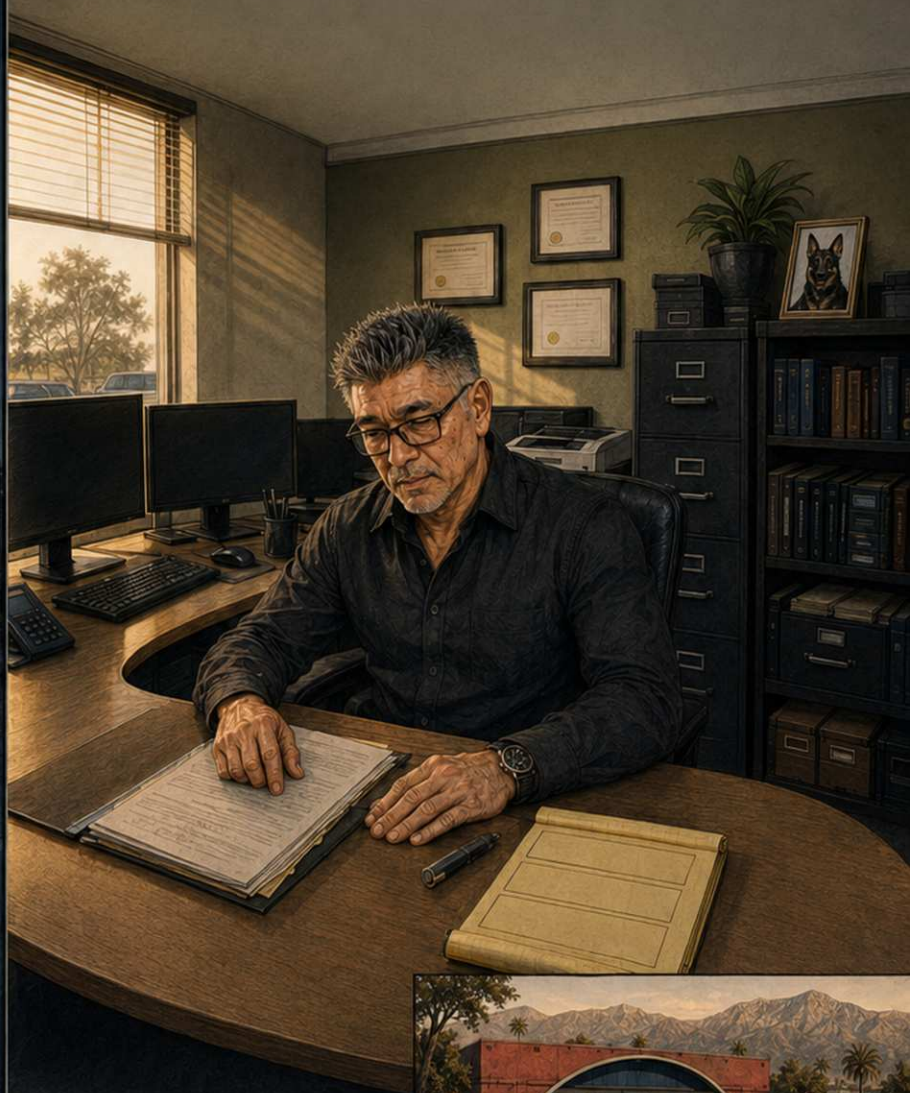
GOOD. THE LEVY IS OVER. THE DEBT ISN'T. NOW WE RESCUE THE CASE.

THE TAX DEBT DETECTIVE WILL RETURN.

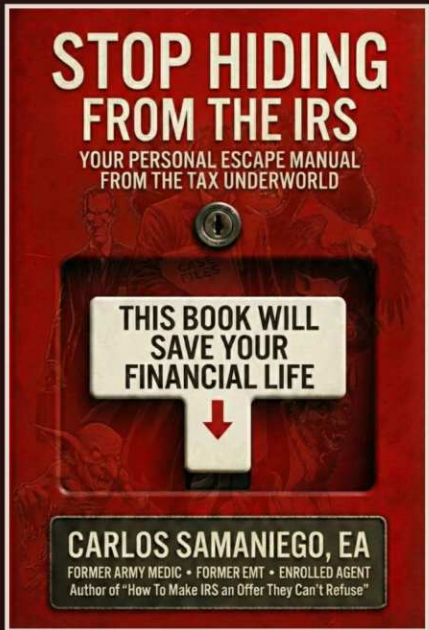
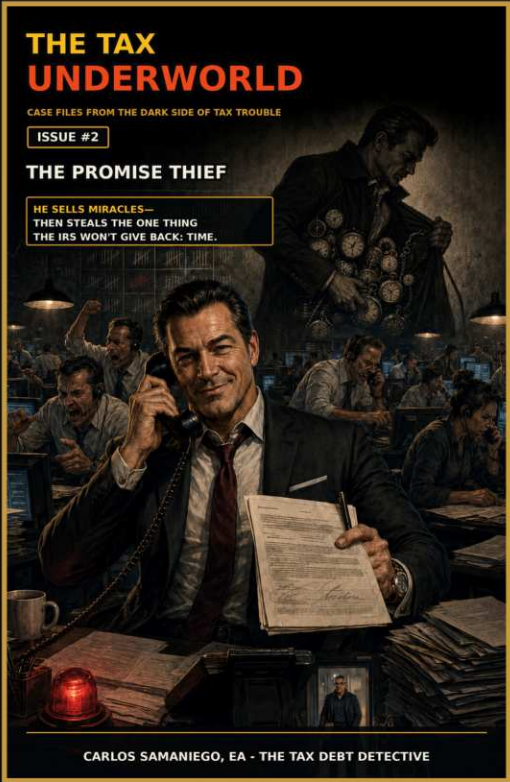
