Scope of Work:

The scope of this project is repair foundation and level building, improve drainage **by diverting water from around the foundation and into the storm drain system and or French drains.**

General Description:

The contractor or contractors are responsible for, but not limited to, the following listed below (Please see Equipment List Unit Information for more detail on each unit):

- 1) *Pre-Construction Walk-Through* – Conduct pre-construction walk-through of the campus to inspect and verify scope of project is aligned to labor and cost.
- 2) *Clean Up* - Contractor shall keep all sites free from the accumulation of waste materials, rubbish; implements and surplus materials. The surrounding premises where the work has been performed must be maintained and cleaned throughout the project. For safety purposes, neither tools, ladders nor any equipment can be left in the area of the job site.
- 3) *Material* - All materials must and will be verified by the selected contractor prior to commencing project.
- 4) *Warranty* - Specify warranty provided.
- 5) *Equipment* - Contractor must have own equipment, HVAC cooling rental equipment (if necessary) and lifts/cranes for project.

- 8) *Liability and Workers Compensation* - Selected contractor must provide proof of General Commercial Liability and Workers Compensation insurance to include School District as an additional issuer.

- 11) *Submittals*- Provide manufacture engineered spec submittals.

Disqualification

No Return of Proposals; Withdrawal of Proposals

Non-Collusion Statement

Proposers are required to certify a Non-Collusive Statement. Proposers are required to state the party submitting a proposal or bid, that such proposal or bid is genuine and not collusive or sham; that proposer has not colluded, conspired, connived or agreed, directly or indirectly, with an entity or person, to put in a sham proposal or bid or to refrain from bidding, and has not in any manner, directly

or indirectly, sought by agreement or collusion, or communication or conference, with any person, to fix the proposal price or of any other proposer, or to fix any overhead, profit or cost element of said proposal price, or of that of any other proposer, or to secure any advantage against LEGACY PREPARTORY CHARTER ACADEMY or any person interested in the proposed contract, and that all statements in said proposal or bid are true.

Open Records Policy

LEGACY PREPARTORY CHARTER ACADEMY is a governmental body subject to the Texas Public Information Act. Proposals submitted to LEGACY PREPARTORY CHARTER ACADEMY as a result of this solicitation may be subject to release as public information after contracts are executed or the procurement is terminated. If a proposer believes that its response, or parts of its response, may be exempted from disclosure under Texas law, the proposer must specify page-by-page and line-by-line the parts of the response which it believes are exempt. In addition, the proposer must specify which exception(s) to the Texas Public Information Act are applicable and provide detailed reasons to substantiate the exception(s). Vague or general claims to confidentiality will not be accepted. LEGACY PREPARTORY CHARTER ACADEMY assumes no obligation or responsibility relating to the disclosure or nondisclosure of information submitted by proposers.

Preferences

LEGACY PREPARTORY CHARTER ACADEMY may apply applicable preferences for Texas resident proposers in the event of a tie bid. Preferences must be explicitly claimed by proposer and may not be applicable in procurements and/or contracts involving federal funds unless the procurement and/or contract involves unprocessed locally grown or locally raised agricultural products for use by LEGACY PREPARTORY CHARTER ACADEMY in a Child Nutrition Program. See Texas Government Code §§ 2252.001 - .004; 2 C.F.R. § 200.319.

Responsible Vendor

A responsible vendor is a vendor who has adequate financial resources (or the ability to obtain such resources), can comply with the delivery requirements, and is a qualified and established firm regularly engaged in the type of business that provides the items listed herein.

Responsive Proposal

The specified article or material shall be understood as indicating type, function, minimum standard of design, efficiency and quality desired and shall not be construed as to exclude other manufactured products or comparable quality, design and efficiency (as applicable).

LEGACY PREPARTORY CHARTER ACADEMY is tax-exempt. Proposal prices should not include taxes.

Sole Source

In order to become a Sole Source Vendor, a proposer must meet the requirements of Texas Education Code § 44.031 (j) Sole Source, as described below.

Selected purchases may be exempt from competitive procurement if they meet the established criteria for a sole source purchase:

- Identification and confirmation that competition in providing the item or product to be purchased is precluded by the existence of a patent, copyright, secret process or monopoly
- Identification and confirmation that the product is a film,

manuscript, book, utility service (including electricity, gas, or water), or a captive replacement part or component for equipment

- Sole source does not apply to mainframe data-processing equipment and peripheral attachments with a single item purchase price in excess of \$15,000.

Conflict of Interest (CIQ Form - must be filled out and attached to proposal in the Response)

The School Legacy Preparatory Charter Academy (LEGACY PREPARTORY CHARTER ACADEMY) is required to comply with Texas Local Government Code Chapter 176, Disclosure of Certain Relationships with Local Government Officers. House Bill 23 significantly changed Chapter 176 as well as the required disclosures and the corresponding forms. As of September 1, 2015, any vendor who does business with LEGACY PREPARTORY CHARTER ACADEMY or who seeks to do business with LEGACY PREPARTORY CHARTER ACADEMY must fill out the new Conflict of Interest Questionnaire (CIQ) whether or not a conflict of interest exists. A conflict of interest exists in the following situations:

"Business relationship" means a connection between two or more parties based on commercial activity of one of the parties. The term does not include a connection based on: (A) a transaction that is subject to rate or fee regulation by a federal, state, or local governmental entity or an agency of a federal, state, or local governmental entity; (B) a transaction conducted at a price and subject to terms available to the public; or

(C) a purchase or lease of goods or services from a person that is chartered by a state or federal agency and that is subject to regular examination by, and reporting to, that agency. *Texas Local Government Code 176.001(3).*

"Family relationship" means a relationship between a person and another person within the third degree by consanguinity or the second degree by affinity, as those terms are defined by Subchapter B, Chapter 573, Government Code. *Texas Local Government Code 176.001(2-a)*.

"Local government officer" means: (A) a member of the governing body of a local governmental entity; (B) a director, superintendent, administrator, president, or other person designated as the executive officer of a local governmental entity; or (C) an agent of a local governmental entity who exercises discretion in the planning, recommending, selecting, or contracting of a vendor. *Texas Local Government Code 176.001(4)*.

In the event of changed circumstances, an updated CIQ must be filed within seven (7) business days after the vendor becomes aware a conflict of interest exists.

EDGAR Conflict of Interest Requirements

In accordance with federal EDGAR requirements, 2 CFR § 318(c)(1), no employee, officer, or agent may participate in the selection, award, or administration of a contract supported by a federal award if he or she has a real or apparent conflict of interest. Such a conflict of interest would arise when the employee, officer, or agent, any member of his or her immediate family, his or her partner, or an organization which employs or is about to employ any of the parties indicated herein, has a financial or other interest in or a tangible personal benefit from a firm considered for a contract.

The officers, employees, and agents of LEGACY PREPARTORY CHARTER ACADEMY may neither solicit nor accept gratuities, favors, or anything of monetary value from contractors or parties to subcontracts. However, through LEGACY PREPARTORY CHARTER ACADEMY's written procedures, LEGACY PREPARTORY CHARTER ACADEMY has set a de minimis amount of less than \$50 per year for items that are unsolicited and of minimal value and promotional items.

Violations of this standard by an employee will be reported to the Superintendent's Office and addressed through LEGACY PREPARTORY CHARTER ACADEMY's personnel policies. Violations of this standard by an officer or the Superintendent shall be addressed to the **Board President and addressed through LEGACY PREPARTORY CHARTER ACADEMY Board policies.**

Certificate of Interested Parties (Form 1295 - must be filled out electronically with the Texas Ethics Commission's online filing application and attached to proposal.

LEGACY PREPARTORY CHARTER ACADEMY is required to comply with House Bill 1295 (84th Leg. Session), which amended the Texas Government Code by adding Section 2252.908, Disclosure of Interested Parties.  - a) who has a controlling interest in a business entity with whom LEGACY PREPARTORY CHARTER ACADEMY contracts; or
 - b) who actively participates in facilitating the contract or negotiating the terms of the contract, including a broker, intermediary, adviser, or attorney for the business entity. TEX. GOV'T CODE §2252.903(3).
- (3) **"Controlling interest"** means:
 - a) an ownership interest or participating interest in a business entity by virtue of units, percentage, shares, stock, or otherwise that exceeds 10 percent;
 - b) membership on the board of directors or other governing body of a business entity of which the board or other governing body is composed of not more than 10 members; or
 - c) service as an officer of a business entity that has four or fewer officers, or service as one of the four officers most highly compensated by a business entity that has more than four officers. *Subsection (c) does not apply to an officer of a publicly held business entity or its wholly owned subsidiaries.* TEX. ETHICS COMM. RULE 46.3(c).
- (4) **"Intermediary"** means a person who actively participates in the facilitation of the contract or negotiating the contract, including a broker, adviser, attorney, or representative of or agent for the business entity who:
 - a) receives compensation from the business entity for the person's participation;
 - b) communicates directly with the governmental entity or state agency on behalf of the business entity regarding the contract; and
 - c) is not an employee of the business entity. TEX. ETHICS COMM. RULE 46.3(e).

These General Terms and Conditions are part of the final contract in each commodity and/or service contract and are part of the terms and conditions of each purchase order or other bid/proposal forms issued in connection with this solicitation.

Proposers are responsible for identifying any exceptions to these terms and conditions.

ANY EXCEPTIONS MUST BE NOTED IN THE "SUPPLIER NOTES TO BUYER SECTION" OF THE EBID SYSTEM.

Proposals that are qualified with conditional clauses, items not called for, or other irregularities may be considered non-responsive by LEGACY PREPARTORY CHARTER ACADEMY and eliminated from further consideration by LEGACY PREPARTORY CHARTER ACADEMY .

This Agreement is entered into between The School Legacy Preparatory Charter Academy ("LEGACY PREPARTORY CHARTER ACADEMY ") and Vendor, having submitted a proposal in response to a procurement solicitation issued by LEGACY PREPARTORY CHARTER ACADEMY and whose proposal has been accepted and awarded by LEGACY PREPARTORY CHARTER ACADEMY . In consideration of the mutual covenants and conditions contained in this Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, LEGACY PREPARTORY CHARTER ACADEMY and Vendor, intending to be legally bound, and subject to the terms, conditions, and provisions of this Agreement, agree as follows:

Agreement Terms; Amendment

The terms of this Agreement shall govern all procurements conducted hereunder. No pre- published terms on the Vendor's order acknowledgments, invoices, or other forms shall have any force or effect. Further, no amendment of this Agreement shall be permitted unless first approved in writing by LEGACY PREPARTORY CHARTER ACADEMY , and no such amendments shall have any effect unless and until a written amendment to this Agreement is executed by LEGACY PREPARTORY CHARTER ACADEMY 's Superintendent or its Chief Financial Officer (or their designees) after any necessary approvals have been obtained from the LEGACY PREPARTORY CHARTER ACADEMY Board of Trustees.

Assignment of Agreement

Vendor may not assign this Agreement or any of its rights, duties, or obligations hereunder without the prior written approval of LEGACY PREPARTORY CHARTER ACADEMY . Any attempted assignment of this Agreement by Vendor shall be null and void. Any purchase or work order made as a result of this Agreement may not be transferred, assigned, subcontracted, mortgaged, pledged, or otherwise disposed of or encumbered in any way by Vendor without the prior written approval of LEGACY PREPARTORY CHARTER ACADEMY . Vendor is required to notify LEGACY PREPARTORY CHARTER ACADEMY when any material change in operations occurs, including but not limited to, changes in distribution rights for awarded products, bankruptcy, material changes in financial condition, change of ownership, and the like, within three (3) business days of such change.

Catalog Discounts

In the event of a catalog discount type proposal, Vendor may be allowed to make addition

and/or deletions from Vendor's offerings on an annual basis during the Agreement renewal period, in LEGACY PREPARTORY CHARTER ACADEMY 's sole discretion, provided the item(s) substituted are of a like quality and category. These changes will be compliant with the format of Vendor's original proposal (i.e. manufacturer name, product category, or entire catalog discount). LEGACY PREPARTORY CHARTER ACADEMY will send notification to Vendor(s) seeking any additions and/or deletions, and Vendor will return these proposed changes on company letterhead within the given timeframe. If LEGACY PREPARTORY CHARTER ACADEMY , in its sole discretion, accepts Vendor's proposed changes, such changes will remain in effect for the entire year until the next renewal period.

Certifications

Vendor hereby certifies that it is not a company identified on the Texas Comptroller's list of companies known to have contracts with, or provide supplies or services to, a foreign organization designated as a Foreign Terrorist Organization by the U.S. Secretary of State. Vendor further certifies and verifies that neither Vendor, nor any affiliate, subsidiary, or parent company of Vendor, if any (the "Vendor Companies"), boycotts Israel, and Vendor agrees that Vendor and Vendor Companies will not boycott Israel during the term of this Agreement. For purposes of this Agreement, the term "boycott" shall mean and include terminating business activities or otherwise taking any action that is intended to penalize, inflict economic harm on, or limit commercial relations with Israel, or with a person or entity doing business in Israel or in an Israeli- controlled territory.

Vendor certifies and agrees that it shall not assist an employee, contractor, or agent of LEGACY PREPARTORY CHARTER ACADEMY or of any other school Legacy Preparatory Charter Academy in obtaining a new job if the Vendor knows, or has probable cause to believe, that the individual engaged in sexual misconduct regarding a minor or student in violation of the law. Routine transmission of an administrative or personnel file does not violate this prohibition. See LEGACY PREPARTORY CHARTER ACADEMY Policy CJ (Legal) and (Local).

Compliance with Laws

Vendor shall comply with all applicable federal, state, and local laws, statutes, ordinances, standards, orders, rules, and regulations, including, as applicable, workers' compensation laws, minimum and maximum salary and wage statutes and regulations, prompt payment and licensing laws and regulations, the Davis-Bacon Act (40 U.S.C. § 276a I 29 CFR Part 5), the Copeland "Anti-Kickback" Act (18 U.S.C. § 874 I 29 CFR Part 5), the Equal Opportunity Employment requirements (Executive Orders 11246 and 11375 I 41 CFR Chapter 60), the McNamara-O'Hara Service Contract Act (41 U.S.C. 351), Section 306 of the Clean Air Act (42 U.S.C. § 1857h, Section 508 of the Clean Water Act (33 U.S.C. § 1368), Executive Order 11738, Environmental Protection Agency regulations (40 CFR Part 15), the Contract Work Hours and Safety Act (40 U.S.C. § 3701- 3708; 29 C.F.R. Part 5), the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (2 CFR Part 200), the Education Department General Administrative Regulations, 2 C.F.R. Parts 200 and 3474, and 34 C.F.R. Parts 75-77 and 81 ("EDGAR"), mandatory standards and policies contained in the state energy conservation plan issued in compliance with the Energy Policy and Conservation Act (Pub. L. 94- 163, 89 Stat. 871), and all applicable requirements and regulations, including those related to reporting, patent rights, copyrights, data rights and those mandated by federal agencies making awards of federal funds to LEGACY PREPARTORY CHARTER ACADEMY . Vendor understands that Vendor is ineligible to receive a contract award with LEGACY PREPARTORY CHARTER ACADEMY if Vendor or its principal(s) is listed on the government wide exclusions in the System for Award Management (Debarment and Suspension Orders Executive Orders 12549 and 12689) or is 30 days or more delinquent in paying child support (Tex. Fam. Code § 231.006). For the entire duration of this Contract, Vendor and all subcontractors shall maintain all required licenses, certifications, permits, and any other documentation necessary

to perform this Contract. Vendor must comply with all state and local building code requirements unless otherwise specifically provided in the LEGACY PREPATORY CHARTER ACADEMY 's Purchase Order, and Vendor must pay all fees and charges for connections to outside services and for use of property outside the project site.

When required or requested by LEGACY PREPATORY CHARTER ACADEMY , Vendor shall furnish LEGACY PREPATORY CHARTER ACADEMY with satisfactory proof of Vendor's compliance with this provision.

Confidentiality

Vendor and LEGACY PREPATORY CHARTER ACADEMY agree to secure the confidentiality of all information and records in accordance with applicable federal and state laws, rules, and regulations. Vendor and LEGACY PREPATORY CHARTER ACADEMY understand that the Family Educational Rights and Privacy Act (FERPA), 20 U.S.C. § 1232g, governs the privacy and security of educational records and information and agree to abide by FERPA rules and regulations, as applicable. Vendor also acknowledges that LEGACY PREPATORY CHARTER ACADEMY is subject to the Texas Public Information Act, and Vendor waives any claim against and releases from liability LEGACY PREPATORY CHARTER ACADEMY , its officers, employees, agents, and attorneys with respect to disclosure of information provided under or in this Agreement or otherwise created, assembled, maintained, or held by Vendor and determined by LEGACY PREPATORY CHARTER ACADEMY , the Attorney General of Texas, or a court of law to be subject to disclosure under the Texas Public Information Act.

Contract Term

The initial term of the Agreement is for a period of one (1) year, with LEGACY PREPATORY CHARTER ACADEMY having the option to renew the Agreement for four (4) additional years in one (1) year increments. Consequently, the total term of the Agreement may be for a period of five (5) years. The phrase "Term" in this Agreement shall mean the then- current Term of the Agreement, whether the initial term or a renewal term.

Criminal History Review (SB 9 Contractor Certification: Contractor Employees Form; SB 9 Contractor Certification: Subcontractor Form - must be filled out and attached to proposal in the Response Attachment section, if applicable)

Prior to commencing any work under the Agreement, if Vendor contracts with LEGACY PREPATORY CHARTER ACADEMY to provide services, Vendor must certify, on the form provided herein, that for each covered employee of Vendor who will have direct contact with students, Vendor has obtained, as required by Texas Education Code Section 22.0834: (a) state criminal history record information from a law enforcement or criminal justice agency or a private entity that is a consumer reporting agency governed by the Fair Credit Reporting Act (15 U.S.C. Section 1681 et seq.) for each covered employee of Vendor employed before January 1, 2008; and (b) national criminal history record information for each employee of Vendor employed on or after January 1, 2008. Vendor must also obtain similar certifications of compliance with Texas Education Code Chapter 22's requirements from any subcontractors on the form provided herein. Covered employees with disqualifying criminal history are prohibited from serving at LEGACY PREPATORY CHARTER ACADEMY ; Vendor and any subcontracting entity may not permit a covered employee to provide services at a school if the employee has been convicted of a felony or misdemeanor offense that would prevent a person from being employed under Tex. Educ. Code § 22.085(a) (i.e., Title 5 felony or an offense requiring registration as a sex offender and victim was under 18 years of age or was enrolled in a public school at the time the offense occurred).

Covered employees do not include employees of a contracting or subcontracting entity that is providing engineering, architectural, or construction services on a project to design, construct, alter, or repair a public work if: (1) the public work does not involve the construction, alteration, or repair of an instructional facility as defined by Texas Education Code Section 46.001; (2) the employee's duties will be completed

more than seven (7) days before a new instructional facility will be used for instruction; or (3) for an existing instructional facility, the work area contains sanitary facilities separated from all areas used by students by a fence at least six (6) feet high, and the Contractor adopts, informs employees of, and enforces a policy prohibiting employees and any subcontractor's employees from interacting with students or entering areas used by students. Tex. Educ. Code §§ 22.0834(a-1), .08341. The criminal history record information review obligation applies if Vendor contracts with LEGACY PREPARTORY CHARTER ACADEMY to provide services; it does not apply to a contract for the purchase of goods or real estate.

Customer Reference List

Vendor agrees to submit a customer reference list upon request by LEGACY PREPARTORY CHARTER ACADEMY .

Customer Support

Vendor shall provide timely and accurate technical advice and sales support to LEGACY PREPARTORY CHARTER ACADEMY and LEGACY PREPARTORY CHARTER ACADEMY staff. Vendor shall respond to requests for customer support within one (1) business day after receipt of the request. Vendor shall provide training to LEGACY PREPARTORY CHARTER ACADEMY staff regarding products and/or services supplied by Vendor, at no additional charge, if requested by LEGACY PREPARTORY CHARTER ACADEMY .

Entire Agreement

This Agreement, the procurement solicitation issued by LEGACY PREPARTORY CHARTER ACADEMY , and Vendor's proposal submitted in response to LEGACY PREPARTORY CHARTER ACADEMY 's procurement solicitation, and the attached and incorporated addendum or exhibits, if any, contain the entire agreement of the parties relative to the purpose(s) of the Agreement and supersede any other representations, agreements, arrangements, negotiations, or understanding, oral or written, between the parties to this Agreement. In the event of a conflict between this Agreement and the procurement solicitation issued by LEGACY PREPARTORY CHARTER ACADEMY or Vendor's proposal submitted in response to LEGACY PREPARTORY CHARTER ACADEMY 's procurement solicitation, this Agreement shall control. In the event of a conflict between the procurement solicitation issued by LEGACY PREPARTORY CHARTER ACADEMY and Vendor's proposal submitted in response to LEGACY PREPARTORY CHARTER ACADEMY 's procurement solicitation, LEGACY PREPARTORY CHARTER ACADEMY 's procurement solicitation shall control. This Agreement supersedes any conflicting terms and conditions on any purchase or work orders, invoices, checks, order acknowledgements, forms, purchase orders, or similar commercial documents relating hereto and which may be issued by Vendor after the Effective Date of this Agreement.

Equal Opportunity

It is the policy of LEGACY PREPARTORY CHARTER ACADEMY not to discriminate on the basis of race, color, National origin, gender, limited English proficiency or handicapping conditions in its programs. Vendor agrees not to discriminate against any employee or applicant for employment to be employed in the performance of this Agreement, with respect to hire, tenure, terms, conditions and privileges of employment, or a matter directly or indirectly related to employment, because of age (except where based on a bona fide occupational qualification), sex (except where based on a bona fide occupational qualification) or race, color, religion, national origin, or ancestry. Vendor further agrees that every subcontract entered into for the performance of this Agreement shall contain a provision requiring non- discrimination in employment herein specified, binding upon each subcontractor. Breach of this covenant may be regarded as a material breach of the Agreement.

Force Majeure

Neither LEGACY PREPARTORY CHARTER ACADEMY or Vendor shall be deemed to have breached any provision of this Agreement as a result of any delay, failure in performance, or interruption of service resulting directly or indirectly from acts of God, network failures, acts of civil or military authorities, civil disturbances, wars, energy crises, fires, transportation contingencies, interruptions

in third-party telecommunications or Internet equipment or service, other catastrophes, or any other occurrences which are reasonably beyond such party's control.

The parties to this Agreement are required to use due caution and preventive measures to protect against the effects of force majeure, and the burden of proving that a force majeure event has occurred shall rest on the party seeking relief under this provision. The party seeking relief due to force majeure is required to promptly notify the other party in writing, citing the details of the force majeure event and relief sought, and shall resume performance immediately after the obstacles to performance caused by a force majeure event have been removed, provided the Agreement has not been terminated. Delay or failure of performance, by either party to this Agreement, caused solely by a force majeure event, shall be excused for the period of delay caused solely by the force majeure event. Neither party shall have any claim for damages against the other resulting from delays caused solely by force majeure. Notwithstanding any other provision of this Agreement, in the event the Vendor's performance of its obligations under this Agreement is delayed or stopped by a force majeure event, LEGACY PREPARTORY CHARTER ACADEMY shall have the option to terminate this Agreement. This section shall not be interpreted as to limit or otherwise modify any of LEGACY PREPARTORY CHARTER ACADEMY 's contractual, legal, or equitable rights.

Governing Law and Venue

The laws of the State of Texas, without regard to its provisions on conflicts of laws, govern this Agreement. The mandatory, exclusive jurisdiction for any dispute under this Agreement is in the state and federal courts located in Hidalgo, County, Texas.

LEGACY PREPARTORY CHARTER ACADEMY Property

In the event of loss, damage, or destruction of any property owned by or loaned by LEGACY PREPARTORY CHARTER ACADEMY that is caused by Vendor or Vendor's representative, agent, employee, or contractor, Vendor shall indemnify LEGACY PREPARTORY CHARTER ACADEMY and pay to LEGACY PREPARTORY CHARTER ACADEMY the full value of or the full cost of repair or replacement of such property, whichever is greater, within thirty (30) days of Vendor's receipt of written notice of LEGACY PREPARTORY CHARTER ACADEMY 's determination of the amount due. If Vendor fails to make timely payment, LEGACY PREPARTORY CHARTER ACADEMY may obtain such money from Vendor by any means permitted by law, including, without limitation, offset or counterclaim against any money otherwise due to Vendor by LEGACY PREPARTORY CHARTER ACADEMY .

Indemnification

VENDOR SHALL INDEMNIFY AND HOLD LEGACY PREPARTORY CHARTER ACADEMY HARMLESS FROM ALL CLAIMS, LIABILITIES, COSTS, SUITS OF LAW OR IN EQUITY, EXPENSES, ATTORNEYS' FEES, FINES, PENALTIES OR DAMAGES ARISING FROM THE ACTS OR OMISSIONS OF VENDOR, VENDOR'S EMPLOYEES, AGENTS, OR SUBCONTRACTORS, IN CONNECTION WITH THIS AGREEMENT, INCLUDING, WITHOUT LIMITATION, THOSE ARISING FROM CLAIMED INFRINGEMENT OF ANY PATENTS, TRADEMARKS, COPYRIGHT OR OTHER CORRESPONDING RIGHT(S) WHICH IS RELATED TO ANY ITEM VENDOR IS REQUIRED TO DELIVER. Vendor's obligations under this clause shall survive acceptance and payment by LEGACY PREPARTORY CHARTER ACADEMY .

Insurance

Vendor is required to provide LEGACY PREPARTORY CHARTER ACADEMY with copies of certificates of insurance, naming LEGACY PREPARTORY CHARTER ACADEMY as an additional insured, for Texas Workman's Compensation and General Liability Insurance. Certificates of Insurance, name and address of Vendor, the limits of liability, the effective dates of each policy, and policy number shall be delivered to LEGACY PREPARTORY CHARTER ACADEMY prior to commencement of any work under this Agreement. The insurance company insuring Vendor shall be licensed in the State of Texas and shall be acceptable to LEGACY PREPARTORY CHARTER ACADEMY . Vendor shall give LEGACY PREPARTORY CHARTER ACADEMY a minimum of ten (10) days' notice prior to any modifications or cancellation of said policies of insurance. Vendor shall require all subcontractors

performing any work under or relating to this Agreement to maintain coverage as specified below.

Minimum Insurance Requirements

- Vendor shall, at all times during the Term of this Agreement, maintain insurance coverage with not less than the type and requirements shown below. Such insurance is to be provided at the sole cost of Vendor. These requirements do not establish limits of Vendor's liability.
 - All policies of insurance shall waive all rights of subrogation against LEGACY PREPARTORY CHARTER ACADEMY , its officers, employees, and agents.
 - Upon request, certified copies of original insurance policies shall be furnished to LEGACY PREPARTORY CHARTER ACADEMY .
 - LEGACY PREPARTORY CHARTER ACADEMY shall be named as an "additional insured" on all insurance policies.
 - LEGACY PREPARTORY CHARTER ACADEMY reserves the right to require additional insurance should LEGACY PREPARTORY CHARTER ACADEMY deem additional insurance necessary, in LEGACY PREPARTORY CHARTER ACADEMY 's sole discretion.
- A. Workers' Compensation (with Waiver of subrogation to LEGACY PREPARTORY CHARTER ACADEMY)Employer's Liability, including all states, U.S. Longshoremen, Harbor Workers and other endorsements.
 - B. Statutory, and Bodily Injury by Accident: \$100,000 each employee.
 - C. Bodily Injury by Disease: \$500,000, policy limit \$100,000 each employee. Commercial General Liability Occurrence Form including, but not limited to, Premises and Operations, Products Liability Broad Form Property Damage, Contractual Liability, Personal and Advertising Injury Liability and where the exposure exists, coverage for watercraft, blasting collapse, and explosions, blowout, catering and underground damage.
 - \$300,000 each occurrence Limit Bodily Injury and Property Damage combined
 - \$300,000 Products-Completed Operations Aggregate Limit \$500,000 per Job Aggregate
 - \$300,000 Personal and Advertising Injury Limit
 - D. Automobile Liability Coverage
 - \$300,000 Combined Liability Limits Bodily Injury and Property Damage Combined.

Interpretation

Vendor agrees that the normal rules of construction that require that any ambiguities in this Agreement are to be construed against the drafter shall not be employed in the interpretation of this Agreement.

Invoices - Payments

Invoices shall be directed to LEGACY PREPARTORY CHARTER ACADEMY 's Accounts Payable Department. All invoices shall be itemized to include the type of good(s) and/or service(s) rendered. Vendor shall submit invoices within a timely manner during LEGACY PREPARTORY CHARTER ACADEMY 's fiscal year in which the good(s) and/or services are purchased. In accordance with Texas Government Code § 2251.021, payments are due to Vendor within forty-five (45) days after the later of the following: (1) the date LEGACY PREPARTORY CHARTER ACADEMY receives the goods under the Agreement; (2) the date the performance of the service under the Agreement is completed; or (3) the date LEGACY PREPARTORY CHARTER ACADEMY receives an invoice for the goods or service. Vendor agrees to pay any subcontractors, if any, the appropriate share of the payment received from LEGACY PREPARTORY CHARTER ACADEMY not later than the tenth (10th) day after the date Vendor receives the payment from LEGACY PREPARTORY CHARTER ACADEMY . The exceptions to payments made by LEGACY PREPARTORY CHARTER ACADEMY and/or Vendor listed in Texas Government Code § 2251.002 shall apply to this Agreement.

IRS W-9

In order to receive payment under this Agreement, Vendor shall have a current I.R.S. W-9 Form on file with LEGACY PREPARTORY CHARTER ACADEMY .

Multiple Contract Awards; Non-Exclusivity

LEGACY PREPARTORY CHARTER ACADEMY reserves the right to award multiple contracts for each

commodity category. Commodity categories are established at the sole discretion of LEGACY PREPARTORY CHARTER ACADEMY . Nothing in this Agreement may be construed to imply that Vendor has the exclusive right to provide products and/or services to LEGACY PREPARTORY CHARTER ACADEMY . During the Term of this Agreement, LEGACY PREPARTORY CHARTER ACADEMY reserves the right to use all available resources to procure other products and/or services as needed and doing so will not violate any rights of Vendor.

New Products

New products that meet the specifications detailed in the solicitation may be added to this Agreement, with prior written approval from LEGACY PREPARTORY CHARTER ACADEMY . Pricing of any new products shall be equivalent to the percentage discount or proposed prices for other similar products. Vendor may replace or add products to an existing contract if: the replacing products are equal to or superior to the original products offered; are discounted in a similar or to a greater degree; and the products meet the requirements of the original solicitation. No products may be added to avoid competitive procurement procedures. LEGACY PREPARTORY CHARTER ACADEMY may reject any proposed additions, without cause, in its sole discretion.

No Substitution

Any order issued pursuant to this Agreement shall conform to the specifications and descriptions identified in this Agreement and in the solicitation. Unless otherwise agreed to in advance by LEGACY PREPARTORY CHARTER ACADEMY , Vendor will not deliver substitutes without prior authorization from LEGACY PREPARTORY CHARTER ACADEMY .

No Agency or Endorsements

LEGACY PREPARTORY CHARTER ACADEMY and Vendor are independent contractors and have no power or authority to assume or create any obligation or responsibility on behalf of the other party. This Agreement shall not be construed or deemed an endorsement of a specific company or product. It is the intention of the parties that Vendor is independent of LEGACY PREPARTORY CHARTER ACADEMY and is not an employee, agent, joint venturer, or partner of LEGACY PREPARTORY CHARTER ACADEMY , and nothing in this Agreement shall be interpreted or construed as creating or establishing the relationship of employer and employee, agent, joint venturer or partner, between LEGACY PREPARTORY CHARTER ACADEMY and Vendor or LEGACY PREPARTORY CHARTER ACADEMY and any of Vendor's agents. Vendor agrees that LEGACY PREPARTORY CHARTER ACADEMY has no responsibility for any conduct of any of Vendor's employees, agents, representatives, contractors, or subcontractors.

Non-Appropriation Clause

Renewal of this Agreement, if any, will be in accordance with Texas Local Government Code §271.903 concerning non-appropriation of funds for multi-year contracts. Notwithstanding any other provision of this Agreement or obligation imposed on LEGACY PREPARTORY CHARTER ACADEMY by this Agreement, LEGACY PREPARTORY CHARTER ACADEMY shall have the right to terminate this Agreement without default or liability to Vendor resulting from such termination, effective as of the expiration of each budget period of LEGACY PREPARTORY CHARTER ACADEMY if it is determined by LEGACY PREPARTORY CHARTER ACADEMY , in LEGACY PREPARTORY CHARTER ACADEMY 's sole discretion, that there are insufficient funds to extend this Agreement. The parties agree that this Agreement is a commitment of LEGACY PREPARTORY CHARTER ACADEMY 's current revenue only.

Notice

Any notice provided under the terms of this Agreement by either party to the other shall be in writing and shall be given by hand-delivery or by certified or registered mail, return receipt requested. Notice shall be sufficient if made or addressed to the address listed in the signature line of this Agreement. Notice shall be deemed effective upon receipt. Each party may change the address at which notice may be sent to that party by giving notice of such change to the other party by certified or registered mail, return receipt requested.

Penalties

If Vendor is unable to provide the goods or services at the prices quoted in Vendor's proposal or if Vendor fails to fulfill or abide by the terms and conditions of the Agreement, LEGACY PREPARTORY CHARTER ACADEMY may take the following action(s), in LEGACY PREPARTORY CHARTER ACADEMY 's sole discretion, and Vendor agrees to comply with LEGACY PREPARTORY CHARTER ACADEMY 's action(s):

- (a) insist that Vendor honor the quoted price(s) specified in Vendor's proposal;
- (b) have Vendor pay the difference between Vendor's price and the price of the next acceptable proposal (as determined by LEGACY PREPARTORY CHARTER ACADEMY);
- (c) have Vendor pay the difference between Vendor's price and the actual purchase price of the good or service on the open market; and/or
- (d) recommend to LEGACY PREPARTORY CHARTER ACADEMY 's Board of Trustees that Vendor no longer be given the opportunity to submit a proposal to LEGACY PREPARTORY CHARTER ACADEMY and/or that this Agreement be terminated.

Performance

Vendor agrees to use best efforts to provide the good(s) and/or service(s) subject to this Agreement.

Performance and Payment Bonds

Vendor agrees to provide performance bonds and/or payment bonds as required by Texas law on specified contracts and/or projects, as applicable. LEGACY PREPARTORY CHARTER ACADEMY will include the performance and payment bonds requirement in the specifications section of any solicitation if performance bonds and/or payment bonds are required.

Prevailing Wage Rates

Vendor and all subcontractors of Vendor shall comply with all laws regarding wage rates including, but not limited to, Texas Government Code Chapter 2258 and any related federal requirements applicable to this Agreement and to this solicitation by LEGACY PREPARTORY CHARTER ACADEMY .

Prices

All prices in Vendor's proposal shall be firm for the Term of the Agreement. All price changes shall be presented to LEGACY PREPARTORY CHARTER ACADEMY for acceptance or rejection by LEGACY PREPARTORY CHARTER ACADEMY , in its sole discretion, using the same format as was accepted in Vendor's original proposal; all price changes for goods and/or services provided under this Agreement must be approved, in writing, by LEGACY PREPARTORY CHARTER ACADEMY prior to taking effect. The following documentation shall be provided to support a request for a price change: justification for change/increase; terms and conditions; market conditions; manufacturers/distributors' impact (if any).

Quantities

Because all commodities will be provided on an "as needed" basis, LEGACY PREPARTORY CHARTER ACADEMY makes no representation either orally or in writing to the amount of commodities, services, or related items LEGACY PREPARTORY CHARTER ACADEMY will use during the Term of the Agreement.

Records Retention

Vendor shall maintain its records and accounts in a manner that shall assure a full accounting for all goods and/or services provided by Vendor to LEGACY PREPARTORY CHARTER ACADEMY under this Agreement. These records and accounts shall be retained by Vendor and made available for audit by LEGACY PREPARTORY CHARTER ACADEMY for a period of not less than three (3) years from the date of completion of the services, receipt of the goods, or the date of the receipt by LEGACY PREPARTORY CHARTER ACADEMY of Vendor's final invoice or claim for payment in connection with this Agreement, whichever is later. If an audit has been announced, Vendor shall retain its records

accounts until such audit has been completed.

Right to Audit

4. Certify that FATCA code(s) entered on this form (if any) indicating that you are exempt from the FATCA reporting, is correct. See *What is FATCA reporting*, later, for further information.

Note: If you are a U.S. person and a requester gives you a form other than Form W-9 to request your TIN, you must use the requester's form if it is substantially similar to this Form W-9.

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien;
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States;
- An estate (other than a foreign estate); or
- A domestic trust (as defined in Regulations section 301.7701-7).

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax under section 1446 on any foreign partners' share of effectively connected taxable income from such business. Further, in certain cases where a Form W-9 has not been received, the rules under section 1446 require a partnership to presume that a partner is a foreign person, and pay the section 1446 withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid section 1446 withholding on your share of partnership income.

In the cases below, the following person must give Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States.

- In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the entity;
- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the trust; and
- In the case of a U.S. trust (other than a grantor trust), the U.S. trust (other than a grantor trust) and not the beneficiaries of the trust.

Foreign person. If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person, do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Pub. 515, Withholding of Tax on Nonresident Aliens and Foreign Entities).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a "saving clause." Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

1. The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
2. The treaty article addressing the income.
3. The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
4. The type and amount of income that qualifies for the exemption from tax.
5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

1. You do not furnish your TIN to the requester,
2. You do not certify your TIN when required (see the instructions for Part II for details),
3. The IRS tells the requester that you furnished an incorrect TIN,
4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only), or
5. You do not certify to the requester that you are not subject to backup withholding under 4 above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See *Exempt payee code*, later, and the separate Instructions for the Requester of Form W-9 for more information.

Also see *Special rules for partnerships*, earlier.

What is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all United States account holders that are specified United States persons. Certain payees are exempt from FATCA reporting. See *Exemption from FATCA reporting code*, later, and the Instructions for the Requester of Form W-9 for more information.

Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you no longer are tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account; for example, if the grantor of a grantor trust dies.

Penalties

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

Specific Instructions

Line 1

You must enter one of the following on this line; **do not** leave this line blank. The name should match the name on your tax return.

If this Form W-9 is for a joint account (other than an account maintained by a foreign financial institution (FFI)), list first, and then circle, the name of the person or entity whose number you entered in Part I of Form W-9. If you are providing Form W-9 to an FFI to document a joint account, each holder of the account that is a U.S. person must provide a Form W-9.

a. **Individual.** Generally, enter the name shown on your tax return. If you have changed your last name without informing the Social Security Administration (SSA) of the name change, enter your first name, the last name as shown on your social security card, and your new last name.

Note: ITIN applicant: Enter your individual name as it was entered on your Form W-7 application, line 1a. This should also be the same as the name you entered on the Form 1040/1040A/1040EZ you filed with your application.

b. **Sole proprietor or single-member LLC.** Enter your individual name as shown on your 1040/1040A/1040EZ on line 1. You may enter your business, trade, or "doing business as" (DBA) name on line 2.

c. **Partnership, LLC that is not a single-member LLC, C corporation, or S corporation.** Enter the entity's name as shown on the entity's tax return on line 1 and any business, trade, or DBA name on line 2.

d. **Other entities.** Enter your name as shown on required U.S. federal tax documents on line 1. This name should match the name shown on the charter or other legal document creating the entity. You may enter any business, trade, or DBA name on line 2.

e. **Disregarded entity.** For U.S. federal tax purposes, an entity that is disregarded as an entity separate from its owner is treated as a "disregarded entity." See Regulations section 301.7701-2(c)(2)(iii). Enter the owner's name on line 1. The name of the entity entered on line 1 should never be a disregarded entity. The name on line 1 should be the name shown on the income tax return on which the income should be reported. For example, if a foreign LLC that is treated as a disregarded entity for U.S. federal tax purposes has a single owner that is a U.S. person, the U.S. owner's name is required to be provided on line 1. If the direct owner of the entity is also a disregarded entity, enter the first owner that is not disregarded for federal tax purposes. Enter the disregarded entity's name on line 2, "Business name/disregarded entity name." If the owner of the disregarded entity is a foreign person, the owner must complete an appropriate Form W-8 instead of a Form W-9. This is the case even if the foreign person has a U.S. TIN.

Line 2

Line 4, Exemptions

If you are exempt from backup withholding and/or FATCA reporting, enter in the appropriate space on line 4 any code(s) that may apply to you.

Exempt payee code.

- Except as provided below, corporations are exempt from backup withholding for certain payments, including interest and dividends.

Line 5

Line 6

Enter your city, state, and ZIP code.

Part I. Taxpayer Identification Number (TIN)

Enter your TIN in the appropriate box. If you are a resident alien and you do not have and are not eligible to get an SSN, your TIN is your IRS individual taxpayer identification number (ITIN). Enter it in the social security number box. If you do not have an ITIN, see *How to get a TIN* below.

If you are a sole proprietor and you have an EIN, you may enter either your SSN or EIN.

Go to www.irs.gov/Forms to view, download, or print Form W-7 and/or Form SS-4. Or, you can go to www.irs.gov/OrderForms to place an order and have Form W-7 and/or SS-4 mailed to you within 10 business days.

If you are asked to complete Form W-9 but do not have a TIN, apply for a TIN and write "Applied For" in the space for the TIN, sign and date the form, and give it to the requester. For interest and dividend payments, and certain payments made with respect to readily tradable instruments, generally you will have 60 days to get a TIN and give it to the requester before you are subject to backup withholding on payments. The 60-day rule does not apply to other types of payments. You will be subject to backup withholding on all such payments until you provide your TIN to the requester.

Note: Entering "Applied For" means that you have already applied for a TIN or that you intend to apply for one soon.

Caution: A disregarded U.S. entity that has a foreign owner must use the appropriate Form W-8.

Part II. Certification

Secure Your Tax Records From Identity Theft

Identity theft occurs when someone uses your personal information such as your name, SSN, or other identifying information, without your permission, to commit fraud or other crimes. An identity thief may use your SSN to get a job or may file a tax return using your SSN to receive a refund.

To reduce your risk:

- Protect your SSN,
- Ensure your employer is protecting your SSN, and
- Be careful when choosing a tax preparer.

If your tax records are affected by identity theft and you receive a notice from the IRS, respond right away to the name and phone number printed on the IRS notice or letter.

If your tax records are not currently affected by identity theft but you think you are at risk due to a lost or stolen purse or wallet, questionable credit card activity or credit report, contact the IRS Identity Theft Hotline at 1-800-908-4490 or submit Form 14039.

For more information, see Pub. 5027, Identity Theft Information for Taxpayers.

Victims of identity theft who are experiencing economic harm or a systemic problem, or are seeking help in resolving tax problems that have not been resolved through normal channels, may be eligible for Taxpayer Advocate Service (TAS) assistance. You can reach TAS by calling the TAS toll-free case intake line at 1-877-777-4778 or TTY/TDD 1-800-829-4059.

Protect yourself from suspicious emails or phishing schemes.

Phishing is the creation and use of email and websites designed to mimic legitimate business emails and websites. The most common act is sending an email to a user falsely claiming to be an established legitimate enterprise in an attempt to scam the user into surrendering private information that will be used for identity theft.

The IRS does not initiate contacts with taxpayers via emails. Also, the IRS does not request personal detailed information through email or ask taxpayers for the PIN numbers, passwords, or similar secret access information for their credit card, bank, or other financial accounts.

If you receive an unsolicited email claiming to be from the IRS, forward this message to phishing@irs.gov. You may also report misuse of the IRS name, logo, or other IRS property to the Treasury Inspector General for Tax Administration (TIGTA) at 1-800-366-4484. You can forward suspicious emails to the Federal Trade Commission at spam@uce.gov or report them at www.ftc.gov/complaint. You can contact the FTC at www.ftc.gov/idtheft or 877-IDTHEFT (877-438-4338). If you have been the victim of identity theft, see www.IdentityTheft.gov and Pub. 5027.

Visit www.irs.gov/IdentityTheft to learn more about identity theft and how to reduce your risk.

Privacy Act Notice

Section 6109 of the Internal Revenue Code requires you to provide your correct TIN to persons (including federal agencies) who are required to file information returns with the IRS to report interest, dividends, or certain other income paid to you; mortgage interest you paid; the acquisition or abandonment of secured property; the cancellation of debt; or contributions you made to an IRA, Archer MSA, or HSA. The person collecting this form uses the information on the form to file information returns with the IRS, reporting the above information. Routine uses of this information include giving it to the Department of Justice for civil and criminal litigation and to cities, states, the Legacy Preparatory Charter Academy of Columbia, and U.S. commonwealths and possessions for use in administering their laws. Instructions for the Conflict of Interest Questionnaire

Section 176.006 requires disclosure of a person's "affiliations or business relations that might cause a conflict of interest." The term "affiliation" is not defined in Chapter 176. However, the general definition of the word "affiliation" would mean any association or connection. So any affiliation, including such things as friendship, membership in some group or organization, relationship by blood or marriage, or any other connection, must be disclosed.

How to fill out the Conflict of Interest Questionnaire (each number corresponds with the number on Form CIQ).
